NARRATIVE

- 1. On 22 December 1944, 1st Tank Destroyer Group, consisting of Head-quarters and Headquarters Company, 1st Tank Destroyer Group, moved by vehicle in two (2) convoy groups from vicinity of KORNELIMUNSTER, GERMANY (904377) to vicinity MAFFE, BELGIUM (300998). The leading vehicle cleared KORNELIMUNSTER, GERMANY at 1030A and the new Command Post opened vicinity MAFFE, BELGIUM 1800A. Complete convoy closed in new area 2030A. The roads were wet and slippery. The weather was overcast and murky. Authority for movement: VCCG, VII Corps, 21 December 1944. Order of movement: Letter, VII Corps, subject, Movement of Command Post, dated 21 December 1944.
- 2. On 25 December, lat Tank Destroyer Group, consisting of "eadquarters and "eadquarters Company, 1st Tank Destroyer Group, moved by infiltration from vicihity MAFFE, BELGIUM (900998) to vicinity BORSU, BELGIUM (284016). Closed old Command Post at 1400A and opened new Command Post at 1440A. The condition of roads was good. The weather was cold and clear. Authority for movement: VCCG VII Corps, 24 December 1944. Order of movement: "etter, "eadquarters Company, VII Corps, subject, Movement of Sections to Supply Echelon, dated 25 December 1944.





APPENDIX #1

ANTI-AIRBORNE AND SECURITY MISSIONS

1. Anti-Airborne -

- a. On 16 October 1944, the Commanding Officer, Hq 1st Tank Destroyer Group was charged with the mission of organizing the local defense against airborne attack in the Corps rear area, and coordinating this defense with that of adjacent Division and Corps areas. Auth: VCCG, VII Corps, 16 October 1944, and letter, Headquarters VII Corps, subject, VII Corps Anti-Parachute Defense, dated 17 October 1944.
- b. Colonel BUR OWES G. STEVENS, 012187, Infantry, Commanding Officer, lat Tank Destroyer Group, was announced Anti-Parachute Defense Officer, VII Corps, por Far 1, General order #70, hq VII Corps, 19 October 1944.
 - c. Period of mission 16 October 1944 to present date.
- 2. INTERNAL SECURITY OF CORPS AREA -
- a. Colonel BURROWES G. STEVENS, 012187, Infantry, Commanding Officer, 1st Tank Restroyer Group, was designated Security Commander, VII Corps, per Par 3a, Opns Memo 128, VII Corps, 8 December 1944.
- b. Mission Colonel BURROWES G. STEVENS, Ol2187, Infantry, Commanding Officer, 1st Tank Destroyer Group, is responsible for organizing and supervising the area in rear of the division rear boundaries and forward of the Corps rear boundary to provide for local security at supply installations, units in rear areas, and lines of communication against airborne attack, enemy patrols, guerrilas, snipers, sabotage and other small scale enemy activities. Coordination between areas in the Corps Area and between the Corps Area and Division Areas is a Corps responsibility.
 - c. Period of mission 8 December 1944 to present date.
