1. In compliance with the provisions of AR 345-105, the following information on activities of this unit for the month of January 1945 is submitted.

a. Original unit: 643d Tank Destroyer Battalion. No change.
b. No change in organization. Attached to XVIII Corps, Airborne, on 1 January 1945 and remained attached for entire period.

c. Strength as of 31 December 1944: 33 Officers, 2 Warrant Officers and 692 Enlisted Men, of which 28 Officers, 2 Warrant Officers and 534 Enlisted Men were present for duty. Company A (-2 Platoons) and 2 Reconnaissance Platoons of Headquarters Company, were at Juliouville, France. The period closed with all units present and 31 Officers, 2 Warrant Officers and 636 Enlisted men present.

d. No permanent station. See Appendix I for bivouacs and camps.

e. Marches: See Appendix I.

f. Campaign: No official name received by this headquarters, believed to be part of the Battle of Germany.

g. Battles: Repel German attack in the bulge. See Appendix I.



HEADQUARTERS 643D TANK DESTROYER BATTALION APO 654. U.S.ARMY

Narrative 1 - 31 January 1945

The period opened with the Battalion CP at Les Avins, Belgium. Two platoons of Company A were guarding a bridge at Huy, Belgium, Company B was guarding VII Corps Rear and Company C was guarding installations in the vicinity of Marche, Belgium.

On 1 January 1945 the unit was relieved of all assignments, and attached to XVIII Corps and ordered to vicinity of Spa, Belgium. The unit moved 2 January 1945 to Spa where a representative of Corps directed the Commanding Officer to another destination at Havelange, Belgium. From there, the unit proceeded to Paradis, Belgium, arriving there at 021650.

Company B and C were employed in protection of Headquarters 82nd Airborne Division near Haute Bodeux, Belgium on 3 January 1945. These two units were then employed in assisting the advance of the 82nd Airborne Division for the period 3 - 11 January 1945. On 11 January 1945, they reverted to Corps Reserve. Two men were killed and 19 men were wounded.


Company A (2 platoons) and 2 Reconnaissance platoons of Headquarters Company arrived in Paradis, Belgium 9 January 1945 from Jullouville, France after being relieved of their assignment and ordered returned to the unit by orders of Headquarters, European Theater of Operations, United States Army. Four men injured and hospitalized enroute. The company stayed in Paradis, Belgium in Corps Reserve until 11 January 1945 when they were committed to action with the 106th Infantry Division in the vicinity of Lerriere Spai, Belgium.

The battalion, less Company A moved to Sart, Belgium 14 January 1945 remaining in Corps Reserve and moved to Andrimont, Belgium on 17 January 1945. Company B billeted in vicinity of Moulen-Ruy, Belgium and Company C in the vicinity of Bergimont, Belgium.

Company A was relieved from attached to 106th Infantry Division and returned to billets in vicinity of Cour, Belgium on 19 January 1945. Losses were one man died and 7 men wounded in action. One gun platoon remained attached to 30th Infantry Division and were relieved 20 January 1945, arriving in billeting area, 21 January 1945.

Entire unit remained in Corps Reserve 20-23 January 1945. On 24 January 1945, company B was attached to a unit of the 30th Infantry Division and took up positions vicinity of Diedenberg, Belgium.

Unit, less Company B attached to 82nd Airborne Division on 25 January 1945 and moved 27 January 1945 to vicinity Nieder-Emmeis, Belgium.


Battalion CP moved to Malmedy, Belgium 29 January 1945. Company B released from 30th Infantry Division, attached to 82nd Airborne Division and moved to Madell, Belgium. Company A moved to Wallerode, Belgium on 30 January 1945. On 31 January 1945 Company A moved to Wereth, Belgium and Company C moved to Medell, Belgium. The period closed with the units in these locations. No action with the enemy actually occurred, although combat units were in offensive positions when the period closed.






