DAY BY DAY RECORD OF EVENIS

On the 11th of May the Battalion minus Reconnaissance Company assembled in and around the vicinity of HAAR, 10 Kilometers southeast of MUNICH. Reconnaissance Company, however, still remained attached to T-Force Readquarters, 6th Army Group, with one platoon, stationed in Berchtesgaden, Germany to invistigate any military targets in that particular area.

On the 14th of May the Battalion minus 3 platoon of Reconnaissance Company, was attached to the 45th Division Artillery and moved to an area vicinity of HILGENTSHAUSEN, 20 Kilometers North of DACHAU, GERMANY. Each commany was assigned to an area to police, patrol, and maintain law and order. (See overlay for that date). Traffic control posts were set up in strategic places to stop all vehicles and civilians and check for proper trip tickets and passes. A program was started to round up all the Displaced Persons, most of whom were forced labor on farms and place them in proper camps where they were fed and clothed by the Military Government.

The 3rd platoon of Reconnaissance Company meanwhile was living a life of ease in their 100 room resort hotel vicinity of Hitlers hide-out. On the 15th of May they received the mission to pick up Von Ribbentrop in a little village 16 Kilometers South of EMRCHTESGADEN, but upon reaching their destination the report proved to be false, and no sign was found of the Nazi leader.

The maintenance crews were kept busy in all of the companies trying to get their battle weary vehicles in proper shape. The M-36 tracks were in bad shape. On the move from HAAR to the new area 7 tanks threw tracks and blocks along the way. On the 19th of May the entire Battalion was attached to the Area Command Dachau under command of General ADAMS, of the 45th Infantry Division and assigned new patrol area and traffic control posts vicinity of DACHAU (see overlay).

Reconnaissance Company rejoined the pattalion and the companies were retated each day on petrols and control posts. An Officer of the Day was set up and reports of any activities were reported to the Bettalion CP, Located in DACHAU.

A training schedulo was inaugurated stressing close order drill, garrison and occupational duties, and the training of personnel to fill posts vacated by the redoployment programs.

On the 30th of May 1945, four of "B" Company perticipated in the 45th Infantry Division Memorial Service parade hold in KONIGS FURT, EVENCH, GARRANK.

By now matrols and handling of displaced persons proved to be more or less routine and no particular problems were encountered. The civilians themselves were no trouble but occassional malfactions by cantenkerous, hungry and revengeful Displaced Persons was encountered.
