1 November 1944 -- Vicinity of Luxembourg, Luxembourg.

Operational strength at end of period: 30 officers, 2 warrant officers, 722 enlisted men. (3 EM returned)

This Battalion, minus 2d Rcn Platoon attached to 83d Division Artillery.

Company A in support of 329th Infantry Regiment. Secondary missions controlled by 322d Field Artillery Battalion. 1st Platoon located in vicinity of Jacobsberg, Luxembourg. Fired 12 rounds 3" HE for registration and registered. Also from 311922 to 010555 fired 25 missions of 100 rounds 3" HE harrassing fire on roads, crossroads, and road intersections in Trierweiler, Fussenich, and Lierberg, Germany. Results unknown. 2d Platoon located in vicinity Mon-Jaeger, Luxembourg. Fired one mission of 31 rounds 3" HE for registration and registered. 3d Platoon located in vicinity Berbourg, Luxembourg. Fired one mission of 25 rounds 3" HE for registration and registered.

Company B under Battalion control. Secondary missions controlled by Groupment B. Company CP located in vicinity of Mondorf, Luxembourg. 1st Platoon located in vicinity of Elvange, Luxembourg and at 1300 fired one mission of 23 rounds 3" HE harrassing fire on towns of Ketchen, Erschweiler, Rustoff, Manderen, and Wochern, Germany. Results unknown. 2d Platoon located in vicinity of Elvange, Luxembourg. Did not fire. On company training schedule. 3d Platoon located in vicinity Elvange, Luxembourg and from 2400 to 0600 fired 11 missions of 52 rounds 3" HE harrassing fire on towns of Wochern, Mennig, Sinz, Oberlenten, Dilmars, and Beuren, Germany. Results unknown. Also at 1430 fired one mission of 14 rounds 3" HE for registration and registered.

Company C in support of 330th Infantry Regiment. Secondary missions controlled by Groupment B. Company CP located in vicinity of Kapenacker, Luxembourg. 1st Platoon located in vicinity Kapenacker, Luxembourg and at 0028 fired one mission of 8 rounds 3" HE harrassing fire into town of Wincheringen, Germany. Results unknown. At 2244 fired one mission of 4 rounds 3" HE harrassing fire into town of Wincheringen, Germany. Results unknown. 2d Platoon located in vicinity Kapenacker, Luxembourg. At 1922 fired one mission of 4 rounds 3" HE harrassing fire into town of Dittlegen, Germany. At 2050 fired one mission of 4 rounds 3" HE harrassing fire into town of Wehr, Germany. At 2328 fired one mission of 4 rounds 3" HE harrassing fire into town of Sudlingen, Germany. Results of all firing unknown. 3d Platoon located in vicinity of Kapenacker, Luxembourg and from 0002 to 2208 fired 30 missions of 78 rounds 3" HE harrassing fire on towns of Machum, Nittel, Mannebock, Fisch, Korrig, and Neider, Germany. Results unknown. No return fire received.

1st Rcn Platoon under Battalion control and located in same area as Battalion CP.

Held in reserve for emergency reconnaissance. On platoon training schedule.

2d Rcn Platoon attached to 329th Infantry Regiment. Platoon CP located in vicinity Berdorf. Platoon assigned mission of securing Berdorf.

This Battalion, minus 2d Recon Platoon, attached to 3rd Division Artillery. Company A in support of 328th Infantry Regiment. Secondary missions controlled by 322d Field Artillery Battalion. Company CP located in vicinity of Ech, Luxembourg. 1st Platoon located in vicinity of Jacobsberg, Luxembourg. Fired one mission of 6 rounds 3" HE for registration and registered. From 1725 to 1818 fired 8 missions of 21 rounds 3" HE harassing fire into town of Leuthaus, Germany. Results unknown. 2d Platoon located in vicinity of Mon-Jaeger, Luxembourg. Fired one mission of 4 rounds 3" HE for registration, and registered. From 1202 to 02051 fired 13 missions of 34 rounds 3" HE harassing fire at road junctions in vicinity of Udelfangen, and Kersch, Germany. Results unknown. 3d Platoon located in vicinity of Berdorf, Luxembourg. Fired one mission of 8 rounds 3" HE for registration and registered. From 011840 to 020012 fired 9 missions of 40 rounds 3" HE harassing fire at railroad tracks vicinity of Neunans; road junctions, and road crossings vicinity of Kersch, Germany. Results unknown.

Company B under Battalion control. Secondary missions controlled by Groupment B. Company CP located in vicinity of Mondorf, Luxembourg. 1st Platoon located in vicinity of Elvange, Luxembourg. At 1400 fired one mission of 21 rounds 3" HE for registration and registered. From 2400 to 0600 fired 12 missions of 60 rounds 3" HE harassing fire on towns of Mersch, Weiler, Metchen, Rustoff, Apach, and Kirsch-le-Sierck, Germany. Results unknown. 2d Platoon located in vicinity of Elvange, Luxembourg. Did not fire. On company training schedule. 3d Platoon located in vicinity of Elvange, Luxembourg. At 1445 fired one mission of 11 rounds 3" HE for registration and registered. At 1455 fired one mission of 24 rounds 3" HE observed, on enemy troop concentrations, located in that vicinity, resulting in troops being dispersed. From 1835 to 2400 fired 7 missions of 36 rounds 3" HE harassing fire on towns of Merschweiler, Metchen, Rustoff, Apach, and Kirsch-le-Sierck, Germany. Results unknown.

At 1400 fired one mission of 25 rounds 3" HE for registration. Platoon did not register. From 0005 to 2259 the platoon fired 8 missions of 40 rounds 3" HE harassing fire on towns of Oresdorf, Mittel, and Lannebock, Germany. Results unknown.

Operational strength at end of period: 31 officers, 2 warrant officers, 716 EM (7 EM KIA - 2 EM SWA)

This Battalion, minus 2d Ren Platoon, attached to 83d Division Artillery. Company A in support of 329th Infantry Regiment. Secondary missions controlled by 322d Field Artillery Battalion. Company CP located in vicinity Bech, Luxembourg. 1st Platoon located in vicinity of Jacobsberg, Luxembourg. From 021855 to 030120 fired 10 missions of 44 rounds 3" HE harrassing fire at roads and road junctions in the vicinity of Kersch, Neuhaus, Mesenich, and Udelfaegen, Germany. Results unknown. 2d Platoon located in vicinity Mon-Jaeger, Luxembourg. Did not fire. On company training schedule. 3d Platoon located in vicinity Berbourg, Luxembourg. From 0209 to 0555 fired 12 missions of 56 rounds 3" HE harrassing fire at roads, and road junctions in the vicinity of Kersch, Neuhaus, Mesenich, and Udelfaegen, Germany. Results unknown.

Company B under Battalion control. Secondary missions controlled by Groupment B. Company CP located in vicinity of Mondorf, Luxembourg. 1st Platoon located in vicinity of Elvange, Luxembourg. From 1305 to 1405 fired one mission of 18 rounds 3" HE for registration, and registered. 2d Platoon located in vicinity of Elvange, Luxembourg. The platoon moved from area located in vicinity of Elvange, Luxembourg, at 1420, and arrived to a cover position (wooded area) located in vicinity of Basse-Kontz, Luxembourg at 1505. The platoon received last minute instructions, then proceeded to move to a firing position located 100 yards from their cover. At 1535 the platoon fired 80 rounds of 3" HE and 40 rounds 3" APC direct fire on enemy strong points including caves, houses, and pill boxes. Platoon salvos inflicted countless number of direct hits on the designated targets. Concrete piercing fuzes (T105) were used in lieu of M48 to demolish the concrete walls of the strong points. Several direct hits were scored on entrances to the caves, causing the entrances to be covered. Results of the mission were the complete demolition of pillboxes, caves, and houses. The platoon then proceeded at 1615 with a strategic withdrawal, under heavy enemy artillery fire, at which time the number one gun received a direct hit from the enemy artillery, knocking out the 3" gun and killing seven (7) enlisted men and, seriously wounding two (2) enlisted men. The platoon, less one gun, returned to the area located in vicinity Elvange, Luxembourg. 3d Platoon located in vicinity Elvange, Luxembourg. From 0001 to 2400 fired 11 missions of 64 rounds 3" HE harrassing fire on towns of Merschweiler, Metchen, Rustoff, Apach, and Kirsch-le-Sierck, Germany. Results unknown. From 1405 to 1445 fired one mission of 18 rounds 3" HE for registration. Platoon failed to register due to poor visibility. From 1855 to 2400 fired 7 missions of 3" HE harrassing fire on towns of Merschweiler, Metchen, Rustoff, Apach, and Kirsch-le-Sierck, Germany. Results unknown. Company C in support of 330th Infantry Regiment. Secondary missions controlled by Groupment B. Company CP located in vicinity Kapenacker, Luxembourg. At 0012 fired one mission of 4 rounds 3" HE harrassing fire into town of Kilzengen, Germany. At 0046 fired one mission of four rounds 3" HE harrassing fire into town of Korrig, Germany. At 0127 fired one mission of 4 rounds 3" HE harrassing fire into town of Bilzengen, Germany. At 0258 fired one mission of 4 rounds 3" HE harrassing fire into town of Wincheringen, Germany. All results of firing unknown. 2d Platoon located in vicinity of Kapenacker, Luxembourg. At 0531 fired one mission of 4 rounds 3" HE
