SECTION III - REPORT AFTER ACTION AGAINST ENEMY

1 March, 1945

1. SITUATION:

a. Battalion attached to the 408th FA Group and prepared for forthcoming action on indirect fire missions.

2. OPERATIONS:

COMPANY "A" -- Fired 11 missions of harrassing fire of 546 rds. HE (NC) and one mission for registration of 6 rds.

COMPANY "B" -- Fired 11 missions of harrassing fire of 558 rds. HE (NC) and one mission counterbattery of 20 rds.

COMPANY "C" -- Fired 14 missions of interdiction for a total of 504 rds. NE (NC) and one mission counterbattery of 24 rds.

RECONNAISSANCE PLATOONS -- First platoon continued to lay and repair telephone wire. Second platoon furnished guard for Battalion CP, maintained and repaired roads.

3. ENEMY ACTIVITY:

Enemy artillery received in the Battalion sector was negligible during this period with no enemy air activity reported.

2 March, 1945

- 1. SITUATION:

 - b. COMMAND POST LOCATIONS:

Battalion rear CP moved forward to present position (972254), otherwise no change.

2. OPERATIONS:

COMPANY "A" -- Fired 4 missions of harrassing fire of 199 rds. HE (NC), 1 mission close support of 12 rds. HE (NC), and 1 mission registration of 8 rds for a total of 219 rds.



COMPANY "B" -- Fired 5 missions of harrassing fire of 208 rds. HE (NC) and 2 missions TOT of 12 rds. for a total of 220 rds.

COMPANY "C" -- Fired 6 missions of interdiction fire of 223 rds. HE (NC) and 3 missions of neutralization fire of 41 rds. for a total of 264 rds.

RECONNAISSANCE PLATOONS -- First Platoon continued to lay and repair wire. Second Platoon furnished guard for Battalion CP, maintained and repaired roads.

3. ENEMY ACTIVITY:

During this period it was relatively quiet in all three Company sectors with some small arms fire being received in the vicinity of GYMNICH (F 3049). No casualties were inflicted on our troops.

3 March, 1945

1. SITUATION:

a. Relieved of duty with 408th FA Group and attached to the 14th Cavalry Group. Battalion moved from vicinity of 972254 to vicinity of BOICH (123357) and assembled. Later in the day the 14th Cavalry Group received an order to begin relief of the First Infantry Division. The Battalion moved to the vicinity of HOCHKIRCHEN (229447) closing its new location at 1930 hours. Battalion rear moved to BOICH (123357) closing at 1845 hours.

2. OPERATIONS:

COMPANY "A" -- Moved from vic. of SCHMIDT to vic. of (118364) and moved again to vic. of HOCHKIRCHEN (229448) closing in its new location at 2030 hours. Plans are being made to fire indirect from vic of PINGSHEIM (265452).

COMPANY "B" -- Moved from vic. of SCHNIDT (051291) to vic. of (105340) and moved again to vic of NORVENICH (231460) closing in its new location at 1930 hours. Company will support the 18th Cavalry Squadron in its mission to hold left flank of line along the ERFT Canal.

COMPANY "C" — Moved from vic of (052308) to vic. of SOLLER (168375) closing in its position at 0830 hours. Company will support the 32nd Cavalry Squadron in its mission to protect the right flank of line along the ERFT Ganal.

RECONNAISSANCE FLATCONS -- First plateon moved with "B" Company and will support the 18th Cavalry Squadren in its mission to held left flank of ERFT Canal. Second plateon moved with Company "C" to vic. of SOLLER (168375) and then later moved to Battalion present location at (229447). It is now held in reserve prepared to reconnoiter on call.

3. ENEMY ACTIVITY:

During this period the enemy was observed digging entrenchments in the vicinity of LIBLAR (F 3546). These were taken under fire and quickly dispersed with several casualties being inflicted. Enemy mortar fire was very light during the period.

4 March, 1945

1. SITUATION:

a. Battalion CP remained in position

2. OPERATIONS:

COMPANY "A" -- Moved two platoons (8 guns) into indirect firing positions in the vicinity of PINGSHEIM (208452). Fired 18 rounds for registration. One platoon is held in reserve and was moved to NORVENICH (331459) for its road net.

COMPANY "B" -- B-1 moved to HEILERHOFE (285474) where it is in direct fire positions and is controlling the town filled with hostile civilians. B-2 moved to DIRMERZHEIM (316478) where it is in direct fire positions and supports Troop C of the 18th Cavalry Squadron in its control of the town. B-3 and Company CP moved to GYMNICH where the platoon is in direct fire positions and controls the south third of the town while A & B Troops of the 18th Cavalry Squadron controls the rest of the town filled with hostile civilians. B-3 caught an enemy patrol trying to infiltrate through our lines and killed one, wounded one, and captured three. No casualties were suffered by B-3. The prisoners were turned over to Dedoy Elue.

COMPANY "C" -- Company moved with C-1 and C-3 to AHREM (315434) where the platoons are in direct fire positions. C-2 is in direct fire positions in vic. of HERRIG (288453). Company supports the 32nd Cavalry Squadron.

RECONNAISSANCE PLATOONS -- First platoon held in reserve by the 18th Cavalry Squadron prepared to support them on call. Second Platoon held in reserve by this unit prepared to meet any emergency.

3. ENEMY ACTIVITY:

One enemy patrol attempted to infiltrate our lines in the vic. of GYMNICH (F 3049) at 2030 hours 3 March. This patrol was intercepted by one of our security outposts. In the resulting action one of the Germans was killed and three taken prisoner, one of which was wounded. Upon interrogation, one of the prisoners who was Polish, stated that their missions was to gather information, also that there was about a half a company holding the town in the general area across the canal Northeast of GYMNICH. He



also stated that at 1900 hours each night an enemy machine gun section sets up at the canal crossing between BRUGGEN (3250) and GYMNICH and each morning at daybreak the section withdraws. The prisoners were turned over to Decoy Blue for further questioning and disposition.

5 March, 1945

1. SITUATION:

a. Battalion CP remained in position. An ex-German soldier was found among civilians of HOCHKIRCHEN (229447) and turned over to First Army PW enclosure.

b. CP LOCATIONS:

2. OPERATIONS:

COMPANY "A" -- Fired four harrassing missions totaling 40 rounds of shell HE (NC). Reserve platoon remained in position in NORVENICH (231459).

COMPANY "B" -- Maintained and improved positions in MEILERHDFE (285474). DIRMERZHEIM (318478) and GYMNICH (302491). Company supports 18th Cavalry Squadron.

COMPANY "C" --- Company CP, C-3 and C-2 moved to LIBLAR (351464) where they assisted in clearing the town of the enemy. C-2 fired 5 rds of APC to destroy one pillbox. C-1 moved to BLESSEM (338464) where it went into direct fire positions covering the southern flank of the position.

RECONNAISSANCE PLATCONS -- First platoon held in reserve by the 18th Cavalry Squadron to support them on call. Second platoon held in reserve by Battalion prepared to reconnoiter on call.

3. ENEMY ACTIVITY:

Enemy mortar fire was limited to 20 rds, falling in the town of GYMNICH (F 302492). One 8 to 10 man enemy patrol operated in and east of GYMNICH late during the period.

6 March, 1945

1. SITUATION:

a. Battalion still in position and attached to the 14th Cavalry Group.

b. CP LOCATIONS:

2. OPERATIONS:

COMPANY "A" --- Fired two destruction missions of 80 rds and one neutralization mission of 18 rds, to register, 10 rds of HE and 3 rds of Star Shell were fired. Total rds fired were HE (NC) - 111 and Star Shell -3. Reserve platoon prepared to move to GYMNICH (302491).

COMPANY "B" -- Maintained and improved defense of area. Made preparations for future operations. Captured two enemy personnel who came from BRUGGEN (323502) to our lines to surrender. Company supports 18th Cavalry Squadron.

COMPANY "C" -- Maintained and improved defense of area. Fired 7 rds of HE and knocked out one machine gun emplacement and neutralized activity of enemy personnel.

RECONNAISSANCE PLATOONS -- The first platoon moved with elements of the 18th Cavalry Squadron to vic of BOLTENBROICH (315551) prepared to jump off to South of east side of Canal. Second Platoon prepared to move to mobile reserve in vicinity of GYMNICH (362491) prepared to assist Rcn 1 if necessary.

3. ENEMY ACTIVITY:

There was no contact with the enemy during the period. During the afternoon about 150 people, reported to be carrying rifles and packs, infiltrated into KOTTINGEN (F 3448). Between 2030 and 2230, a patrol in the KOTTINGEN area made no contact with the enemy. Patrol observed town closely and saw no movement even though a building was observed burning. During the early part of the night, trucks were heard along the BRUGGEN-TURNICH road. Much civilian activity was noted during the day. Civilians entered BRUGGEN in small groups from the east and from the woods vicinity (F 315505). White flags were displayed in windows of houses in KOTTINGEN.

7 March, 1945

1. SITUATION:

- a. No change.
- b. CP LOCATIONS -- No change.
- 2. OPERATIONS:

COMPANY "A" -- First and third platoons in vic of (266456) in indirect fire positions. A-2 is in reserve in vic of GYMNICH (302491)

COMPANY "B" -- Continued to improve positions in vic of GYMNICH (302491). B-1 moved to vic of DIRMERZHEIM (318478) with B-2. B-3 remains in GYMNICH. A total of 5 prisoners were captured by Company B in vic of B-2 and B-3.

COMPANY "C" -- Located vic (351464) continued to maintain and improve defense of area. C-1 moved to vic of KIERDORF (331495) and placed guns in direct fire positions. C-2 in position in LIBLAR (351464). C-3 in position in vic of OBER LIBLAR (363456). Company captured 30 prisoners, 14 of which claimed to be ex-Frenchmen.

RECONNAISSANCE PLATOONS -- Rcn 1 was assigned mission of reconnoitering left flank of troop B, 18th Cavalry Squadron as it took objectives on east bank of ERFT CANAL in 18th Cavalry Squadron sector. Platoon captured one enemy prisoner in vicinity of (300531). All railroad overpasses and underpasses between MODRATH (290549) and KIERDORF (334496) were found demolished. The woods in vicinity of (305535) gave evidence of being an ex-German bivouac area but has been deserted for several days. Ten barracks and twenty ammunition dumps were found in vic (335514) Buildings were empty and no minefields were encountered. Rcn 2 moved to vic of GYMNICH (302491) where it is being held in reserve.

3. ENEMY ACTIVITY:

Enemy stragglers surrendered in towns between TURNICH (F 3052) and LIBLAR (F 3546). Only light resistance was encountered in mopping up this area. A few rounds of mortar and some small arms fire was received from the vicinity of (F 490400).

8 March, 1945

1. SITUATION:

- a. Supports lith Cavalry Group. Moved Battalion CP forward to KOTTINGEN (346486) closing in new location at 1630 hours.
- b. CP LOCATIONS:

2. OPERATIONS:

COMPANY "A" -- Supports fire of 193rd FA Bn. CP located at (370452). A-1 and A-3 are in indirect fire positions in vicinity of (370452) and A-2 is being held in reserve in that area.

COMPANY "B" -- Supports the 18th Cavalry Squadron. CP moved to new location at BRUHL (415478). B-1 moved to vicinity of SCHWADORF (422454) and is in direct fire positions. B-2 moved to BRUHL and covers approaches to that area with direct fire positions. B-3 moved to DORF PINGSDORF (40946)) and covers approaches to that area. Company supports the 18th Cavalry Squadron in clearing all enemy resistance to the Rhine River

COMPANY "C" -- Located at LIBLAR (349465). C-1 located at KIERDORF (331494). C-2 at LIBLAR (349465). C-3 at OBERLIBLAR (363456). Preparations have been made for the Company to move forward in supporting the 32nd Cavalry Squadron in clearing all enemy resistance to the Rhine River. 11 Prisoners were captured.

RECONNAISSANCE PLATOONS — Rcn 1 moved to BRUHL (415478) where it remains in reserve to support the 18th Cavalry Squadron in clearing the area of the enemy. Rcn 2 moved to KOTTINGEN (346486) where it remains in reserve.

3. ENEMY ACTIVITY:

Enemy resistance was ended in the Battalion's zone. Friendly units reported enemy making last minute efforts to escape across the Hvine by barge and ferry. Ferrying activities were reported vic F470580 and F 475502 during the afternoon.

9 March, 1945

2. OPERATIONS:

COMPANY "A" -- Supports fire of 193rd FA Bn. Co Hqs and three platoons moved to vicinity of DORF PINGSDORF (409463) where 1st and 3rd platoons have been placed into indirect fire positions. A-2 is being held in reserve in that vicinity.

COMPANY "B" -- Supports 16th Cavalry Squadron in clearing all enemy resistance in zone to RH_NE. Co Hqs and B-2 remained in BRUHL (415478). B-1 remained in position in vicinity of SCHWADF (422454) and B-3 remained in position in vicinity of DORF PINGSDORF (409464). Platoons maintained and improved defenses of position.

COMPANY "C" -- Supports 32nd Cavalry Squadron in clearing enemy resistance in zone to Rhine. Co. Hqs, C-l and C-2 moved to vicinity of SECHTEM (1447434) where the platoons went into direct fire positions. C-3 moved to HEIDE (390490) where it took up direct fire positions. Two EM's injured; one by small arms fire of Cavalry personnel and one crushed against building by a half-track.

RECOLIMATSSANCE PLATUCNS -- Rcn 1 remains in reserve in BRUHL (415478) Rcn 2 remains in reserve in KOTTINGEN (346486).



3. ENEMY ACTIVITY:

During this period there was a heavy increase in enemy air activity. Frequent groups of enemy fighter planes were reported over the Battalion sector on strafing and light bombing missions along the Rhine river front. This Battalion was not in contact with enemy units during this period.

10 March, 1945

1. SITUATION:

a. Battalion moved its CP to WALBERBERG (423440)

2. OPERATIONS:

COMPANY "A" -- Supports fire of 193rd FA Bn. Remains in indirect fire positions with two platoons, with one platoon in reserve in vicinity of DORF PINGSDORF (409463). Fired nine harrassing missions for a total of 221 rds of shell HE (NC). Captured one German soldier in civilian clothes.

COMPANY "B" -- Supports 18th Cavalry Squadron who have been relieved in position by elements of the First Division. Company assembled in vicinity of BRUHL (415478) prepared to move out.

COMPANY "C" -- Supports 32nd Cavalry Squadron. Company and three platoons located in vicinity of SECHTEM (447434). C-1 and C-3 are in indirect fire positions. C-2 remains in direct fire position. Company registered and fired one mission of destruction of 30 rds HE (NC) destroying one enemy OP.

RECONNAISSANCE PLATOONS -- Rcn 1 remains in reserve in vicinity of BRUHL (415478). Rcn 2 remains in reserve in vicinity of WALBERBERG (423440).

3. ENEMY ACTIVITY:

Enemy infantry was observed digging in at F 509458 and were fired on by one of our companies, resulting in an unestimated number of casualties being inflicted. Enemy air activity was sporadic with frequent forays being made by fighters on straffing missions. Enemy artillery fire was light in intensity during the period.

10 March, 1945

1. SITUATION:

a. Remained in WALBERBERG (423440). Was detached from 14th Cavalry Group and reverted to III Corps control as 102400 March, 1945.

b. CP LOCATIONS: No change.



2. OPERATIONS:

COMPANY "A" - Supports fire of 193rd FA Bn. Remained in indirect fire positions in vicinity of DORF PINGSDORF (409463) until 1300. The company was then assembled in that vicinity ready for movement.

COMPANY "B" -- Supported 18th Cavalry Squadron until 2400 hours. Remained in assembly area vicinity of BRUHL (415474) ready for movement.

COMPANY "C" -- Supported 32nd Cavalry Squadron until 2400 hours. Company located in vicinity of SECHTEM (447434). C-1 and C-3 fired indirect using their own forward observer. Fired ten destruction missions, four harressing missions, and one mission for registration for a total of 220 rds. of HE (NC). Enemy infantry were observed digging in at vic (509458) and were taken under fire. Results: It could be observed that many casualties were inflicted. Company pulled out of position at 2200 hours and assembled, preparing for movement.

RECONNAISSANCE PLATOONS - Ron 1 departed for a mission of doing traffic control work for the III Corps Headquarters. The platoon took four additional officers with it. Ron 2 remained in an assembly area in the vic of WALBERBERG (423440) preparing for movement.

3. ENERY ACTIVITY:

Enemy air activity was again confined to strafing missions. Enemy artillery continued to be light and of a harrassing and interdictory nature.

12 March, 1945

1. SITUATION:

- a. Battalion attached to the 401st FA Group. Forward CP moved from WALBERBERG (423440) to BAD GODESBERG (529318). Arrangements are made to move Battalion to same area.

RECONNAISSANCE PLATOONS -- Rcn 1 and four additional officers are being used as road guides for III Corps traffic control. Rcn 2 assembled at BAD GODESBERG (592318).

Enemy mortar and artillery fire continued to be of a harassing and interdictory nature and of light intensity. Enemy air activity continued to be sporadic and concentrated mainly on straffing missions.

COMPANY "A" -- Reinforces fire of 905 FA Bn. Company moved to new location in BAD CODESBERG (589327) and went into indirect fire positions along north side of city. Guns were laid but not registered. 600 rds of HE delivered to guns.

COMPANY "B" -- Company moved to new location in BAD GODESBERG (598322) and placed guns into defensive positions along west bank of Rhine river during the hours of darkness. A daylight reconnaissance was made for targets on far side of river. One EM wounded in leg by sniper fire.

COMPANY "C" -- Reinforces fire of 809th FA Bn. Company moved to new location southwest of LANNES in vic of (59299) and went into indirect firing positions. Guns were laid but not registered. 600 rds of HE delivered to the guns. Company Commander was seriously wounded in both legs by enemy mortar fire. Evacuated.

RECONNAISSANCE PLATOONS -- Rcn 1 remains with III Corps traffic control Headquarters on special duty. Rcn 2 - two vehicles and one officer have gone across Rhine river to reconnoiter for targets to be taken under fire by the artillery and to adjust that fire if possible. Remainder of platoon remains in reserve.

3. ENERY ACTIVITY:

Enemy mortar and artillery was negligible during the period. Enemy air activity continued although only three fighters were reported over the Battalion sector during the period, one of which was shot down by friendly troops.
