SUBJECT: After Action Against the Enemy Report.

TO: Commanding General, 26th Infantry Division,

APO 26, US Army.

In compliance with paragraph 10, change 4, AR 345-105, the following report is submitted for the period 1 April 45 to 30 April 45 inclusive:

1. PERSONNEL:

a. Total effective strength at beginning of period:

c. Reinforcements received: 13, 12 of which were RTD's.

2. ENEMY:

a. No enemy units of division strength were in contact during this period. During first part of period elements of 159 Inf Div, 6 SS Mtn Div, 11 Pz Div, and 2d Pz Div were identified. Later in period elements of 2d Pz Div were identified. With the few above exceptions, enemy units identified were a great number of small, makeshift, miscellaneous units each day. For example, 40 or 50 different units of Co and Bn strength were often identified in one day. Most of these units were miscellaneous units such as replacements units, training units, march units, rear echelon units such as cooks, straggler units, OCS units, etc. A large number of Hungarian and some Polish and Enusian troops were encountered. A large percentage of PWs taken were in Civilian clothes.

b. During this period the Germany Army continued to disintergrate rapidly and was not capable of organized resistance. At no time was there a definite defense line. Instead, enemy resistance was characterized by delaying actions, road blocks, demolitions, and fire from SA. Enemy was entirely without air and artillery support

and there was almost no mortar fire.

c. No enemy tanks were encountered and enemy was almost without transport. In many instances, enemy resisted stubbornly. In many instances, enemy surrendered without much fight. This was especially true of Hungarians. A large number of enemy soldiers changed to civilian clothes but there were few instances of resistance by soldiers in civilian clothes or by civilians. Enemy was almost without large items of equipment such as artillery, transport, tanks, etc, but was well supplied with SA and other small equipment.

3. OWN OPERATIONS:

a. Throughout the entire period the 818th TD Bn was atchd to the 26 Inf Div, asgd to XII Corps, Third Army. For the first half of the period, the 90th Inf Div was on our left flank and the 11th Armored Div with the 71st Inf Div was on our right flank. During the latter half action in the 11th Armd Div with the 90th Inf Div following up was on our left flank, and the 71st Div, XX Corps was on our right flank.

b. Reserves: During the entire period the gun companies were atchd to the Inf Regts, two of which were on line and one in Div reserve. The 2 gun Cos atchd to the 2 Regts on line, generally had 2 pls in D/S of 2 Inf Bns on line w/ one pl in spt of the Inf Bn in reserve.

c. Summary of Operations. Throughout the period the 818th TD Bn was atchd to the 26 Inf Div which was on the offensive as part of the Third Army drive to the E to the CZECHOSLOVAKIAN border and then SE towards the AUSTRIAN border to link up with the RUSSIAN ARMY driving W from VIENNA. The atk of the Div was met by en resitance, varying from moderate pockets of en foot troops to little or no resistance at all. Practically no en mortar and artillery fire was received, and en armor was void except on 2 occasions when 1 and 3 tanks were seen.

On 1 Apr 45, Co A (less 2d pl) atchd to 104 Inf moved in spt of the atk against scattered resistance. CP moved to BREITENBACH N245983; lst pl to WACHTERSBACH: 3d pl to STEINAU. 2d pl atchd to 26 Rcn Tr moved to GIESEL. Co B atchd to 101 Inf moved in spt of Regt. 1st pl spting Inf Bn, fired on and destroyed an en OP in FULDA. Later 1st pl moved into town. 3d pl to MABERZELL. As of 31 Mar, Co B 1st pl destroyed one en trk. Co C atchd to 328 Inf, sptd Inf in clearing sector. 2d pl fired 2 rds APC & 2 rds HE at en SP gun in OBR MOOS N158077 and destroyed gun. Also fired 2 rds HE into house in NIR-MOOS N158071/h4h/h4st N169097, destroying 1 MG and taking 4 PWs. Co C pls moved to GROSSENLUDER. Rcn Co CP & Pio pl moved to OBERRODE H31172. 1st & 3d pls moved w/ Inf Regts, assisting by reconn of routes. 2d pl moved to HOSENFELD as part of TF under Div control as per Frag O 453. Co C atchd to 328 Inf, moved in spt of Inf Bns against very light resistance. Co CP moved to UNT-HASELBACH Q159208; 1st pl to GASTORF; 2d pl to REISS; 3d pl to STRASS-KIRCHEN. Rcn Co continued patrolling and clearing Div rear and patrolling MSR. 61 German soldiers taken by patrols during day. Bn Hq took 9 Hungarian troops today. d. RESULTS OF OPERATIONS: At the close of the period the 26 Inf Div with

- 818th TD Bn atchd, was driving towards the Austrian border, clearing the sector against light resistance behind the 11th Armd Div, which had elements on or near the border. This was a coordinated attack with the 5th Div, XII Corps on our left flank, and the 13th Armored Div, XX Corps, on our right flank, driving SE on the south side of the DANUBE RIVER. During the month the gun companies accounted for the destruction of 2 enemy trucks, 2 OPs, 3 SP guns, 5 MGs, 3 motorcycles, 2 ammo dumps, 2 20mm AA guns, 1 75mm AT gun, 1 steem locomotive, and 1 ME 109 aircraft 10 enemy known killed and 179 enemy taken prisoner. Rem Co through their patrolling of Div rear, captured a total of 832 enemy soldiers. Hq Co accounted for 20 en killed and 102 taken prisoner. Supply and Evacuation:
- Summary of supply activity during period and factors affecting flow The period covered by this report, the Bn was attached to the 26th Inf Div. The various supply agencies of the Div supplied the Bn with the exception of class V and Ordnance class II which were obtained from the nearest Corps or Army installations. Ordnance requisitions, repair and replacements were handled by the 501st Heavy Tank Ordnance Company. Bogie wheels and rear idlers for the M36 Tank
- Destroyer still remain a very critical item.

 b. Rations for the month consisted of 100% pperational rations with a variety of "10-1", "C", and "K" rations being consumed to the greatest advantage, all of which were delivered to the companies daily. Companies requisitioned on the Bn for all supplies, which are secured as rapidly as possible from the proper supply agencies. Motor maintenance and parts supply was handled by the Bn Motor Officer. The 501st Heavy Tank Ordnance Company provided Third Echelon maintenance in all instances except the emergency cases which we were authorized to take to the 47th Medium Maintenance Company. First and second echelon maintenance was performed by the Battalion Motor Maintenance Platoon and Company Motor Sections.
