It being impracticable for the govt to furn rations and quarters in kind, the Fin Dept will pay in adv the monetary travel alw prescribed in Table II, Par 2 a, AR 35-4520, Apr 30, 1942, at the rate of \$3.00 per man per day for one (1) EM for two and one-third (2-1/3) days each way for travel, and for subsistence for the period of detention at the rate of \$2.25 per man per day for one (1) EM for three (3) days, at the rate of \$1.65 per man per day for one (1) EM for three (3) days and at the rate of \$1.40 per man per day for one (1) EM for twenty-two (22) days; and for quarters at the rate of \$1.50 per man per day for one (1) EM for three (3) days, at the rate of \$1.35 per man per day for one (1) EM for three (3) days, and at the rate of \$1.15 per man per day for one (1) EM for twenty-three (23) days. Travel by privately owned conveyance is not authorized. The travel directed is necessary in the military service. FD 34 P 434-03
