HONORING "MEN OF STEEL"

S. J. Res. 43

Ninety-ninth Congress of the United States of America

AT THE SECOND SESSION

Began and held at the City of Washington on Tuesday, the twenty-first day of January, one thousand nine hundred and eighty-six

Joint Resolution

Authorizing establishment of a memorial to honor the American Armored Force.

Resolved by the Senate and House of Representatives of the United States of America in Congress assembled,

SECTION 1. ESTABLISHMENT OF MEMORIAL.

(a) IN GENERAL.—Subject to subsection (c), the organizations specified in subsection (b) are authorized jointly to establish a memorial on Federal land in the District of Columbia or its environs to honor members of the American Armored Force who have served in armored units. The memorial shall commemorate the exceptional professionalism of the members of the American Armored Force and their efforts to maintain peace worldwide.

(b) ORGANIZATIONS.—The organizations referred to in subsection (a) are: the Armored Force Monument Committee, the United States Armor Association, the United States Field Artillery Association, the World Wars Tank Corps Association, the Veterans of the Battle of the Bulge, the 11th Armored Cavalry Regiment Association, the Tank Destroyer Association, the 1st, 2d, 3d, 4th, 5th, 6th, 7th, 8th, 9th, 10th, 11th, 12th, 13th, 14th, and 16th Armored Division Associations, the Council of Armored Division Associations, and the National Association of Uniformed Services.

(c) STANDARDS.—The memorial shall be established in accordance with the standards set forth in H.R. 4378, as passed by the Senate with amendments on September 10, 1986, and further amended by the House of Representatives on September 29, 1986, except that section 6(b)(1) of H.R. 4378 shall not apply to the memorial.

SEC. 2. PAYMENT OF EXPENSES.

The United States shall not pay any expense of establishment of the memorial.

PATTON MUSEUM OF CAVALRY AND ARMOR



COLLECTION POLICY STATEMENT

31 MAY 1985

1. Acquisitions. The Patton Museum serves as installation property account for all historically significant items owned by Department of the Army at the U.S. Army Armor Center and School. All such items will be considered part of the museum collection. The Patton Museum seeks historically significant items that help fulfill the museum mission. There are three means whereby the museum acquires objects:

a. Transfers. Transfers from other museums and federal agencies. These items are already property of the federal government. They are transferred to the museum for preservation and to fulfill the museum mission.

b. Purchases. The museum only purchases items that cannot be acquired through transfer or donation.

c. Donations. The primary source for new acquisitions is donations from private individuals and groups. Donations to the museum are unconditional and irrevocable. The museum reserves the right to use donated objects at its discretion to accomplish the mission. Since the museum and the museum staff are "interested parties" to any donation, the museum will not provide appraisals for objects donated to the museum. (Donors requiring appraisals for tax purposes must obtain these at their own expense from a qualified appraiser.)

2. Type of Objects Collected. a. Specialized Armor and Mechanized Cavalry Equipment of all nations from World War I to present. One example of each type that was developed for Armor or Mechanized Cavalry will be collected, maintained, and preserved as the U.S. Army's example of that item. Additional examples will be collected for demonstration or exhibit purposes as specific needs develop.

b. General Military Equipment of all nations from World War I to present. Only such items of military equipment which were used with Armor and Mechanized Cavalry equipment will be collected. The quantity of each item will be limited to the number necessary to complete the specialized equipment in the collection. Only objects that had the widest use will be collected. Special variants will not be collected.

c. United States Horse Cavalry from 1775 to 1941. As an introduction to Cavalry and Armor of the 20th Century, the museum exhibits items that provide a background. Only such items as required to provide a historical introduction to Mechanized Cavalry will be collected. Generally, these items will be

collected for a specific exhibit or instructional class. Items collected will be those that had the widest use. Special purpose items or those associated with a personality will not be collected.

d. Association Items. Items that have a special association to one of the following will be collected regardless of the designed use. Each item must be identifiable as having a strong association to:

- (1) Fort Knox area from 1918 to present.
(2) General George S. Patton, Jr.

(3) Other Armor personalities that are both deceased and recorded U.S. Army Center of Military History historical publications for notable Armor or Mechanized Cavalry actions.

e. Library Material. The museum seeks books, manuals, papers, other documents, photographs, slides, films, and other audiovisual materials that provide information on the above categories whether historically significant or not. Personal papers will be limited to those subjects that provide background information of donor and those subjects that provide information on items classified in the above categories. Historically significant items will be accessioned part of the museum collection. Those items that are not historically significant will be accessioned as part of the library. If they are part of the library, accountability will be in accordance with library regulations.

f. Art. Objects created for aesthetic purpose whether paintings, sculpture or other media that are one of a kind or one of a limited series, under the direct control of the artist, are sought. The museum seeks only those objects that depict the role of Armor or Mechanized Cavalry from World War I to present. Athletic trophies, mementos, prizes and unit awards are of transitory significance. They will not be accepted into the museum collection.

3. Honor Recognition. In recognition of the contribution of the donors of objects, the museum will provide letters and certificates of donation. Records of donor information will be retained in the donor file. Donor labels will not be placed on items on exhibit.

4. Loans to the Museum. Loans will be accepted only for specific exhibits or instructional classes. They will be retained by the museum only for the duration of the exhibit or class. The period of the loan will be for one year or less and may be renewed for an aggregate of two years. Loans for a greater period will be submitted, through channels, to the Secretary of the Army in accordance with AR 1-100 for approval.

5. Loans from the Museum. The museum will make loans of objects in the collection to agencies for projects that are consistent with the general goals and

purpose of the museum. Consideration of the individual objects will be determined by the nature of use, security and environmental controls provided by the agency. The museum reserves the right to cancel the loan and recall the objects.

6. Deaccessions. All items in the museum's collection are the property of the U.S. Army. None will be sold or traded or given to any agency outside the control of the Chief of Military History without his approval. Historical properties in the collection that, for reason of duplication or unsuitability to the museum's mission, are considered excess to the museum's needs will be offered to the following agencies in order of priority:

- a. Other U.S. Army Museums.
b. Other Department of Defense or Federal Museums.
c. Museums or other nonprofit institutions in accordance with Chapter X, DoD 4160.21-M.
d. Department of Defense Property Disposal Agency.

Documentation of all deaccessioned objects will be retained in the museum's property records.

 I have noted the recent article regarding the "Armored Force" monument that is being planned for location in Arlington Cenetery. I would appreciate your consideration in including the "Amphibious Tractor Battalions" that were converted from Tank Destroyer Battalions. We were originally designated Armored Infantry and later changed to Armored Branch. You may be well aware of their contribution to the initial assault landings of the Pacific Islands. They were not just troop carrying vehicles as they initiated both infantry support and tactics. Our 672nd Battalion was instrumental in the battle at Manila along with the rescue of prisoners held at Los Banos. This was a coordinated effort with the 11th Airborne. This past year 1985, I took a trip to Killeen, TX to see Fort Hood, enjoyed going through the base. Spent 2 days there going through the museums and other armoured displays. I never was stationed there for training because the 632nd shipped out for the Pacific in April of 1942 before Fort Hood was opened. We started out with 37mm anti-tank guns and then got our M10's while we were in Australia just before we were shipped to New Guinea.  The 671st was activated at Camp Hood and while we were there we held the firing range record for accuracy. I don't remember whether we had M10's or M18's. From there we marched 28 miles north to activate Camp Hood. From there we shipped to Camp Swift for a short time. While there we won the camp basketball tournament by beating the camp MP team. I only remember one member of our team and he was the coach, a Sgt. McIntyre from somewhere in MA. From Camp Swift we were shipped to Fort Knox, KY for a couple of months before going to a camp outside of Seattle, WA for embarkation to Hawaii. Having spent about 5 months in Hawaii we then shipped to the Island of Leyte in the Philippines. We were attached to the 9th Corps along with the 77th Div., 81st Div. and the 98th Div. While there, the U.S. dropped the A-bomb on Japan and Japan surrendered. Our battalion was shipped to Manila where some went one way and some went another.  I've never seen any history on the 815th which went to the Pacific. Perhaps I could help you out with a little information. I hope this leads to a later history in which I would be most interested. First, we all got together at Camp Bowie, TX. Many of us were from NY, IL, MI, PA and WV. We took our basic at Bowie and then moved on to Camp Hood. We had 3" towed guns. Afterwards we went to this Camp in California. It was about 8 miles from Needles, CA and damned hot. We had M10's here. After maneuvers we left from Camp Stoneman for overseas. We stopped at Goodenough Island then on to New Guinea. After New Guinea we went to the Philippines to both Leyte and Luzon. Of course the rains came and I guess they didn't think the tanks could move in the mud so we were broken up. A lot of us went into or formed the 112th Cavalry Regimental Combat Team which was part of the 1st Cavalry Division. We then went through the paddy fields and mountains. We left out of Lingagen Gulf for Japan. It was a tremendous armada of ships of all different sizes loaded with everything thinkable. Our ship was along side of the battleship, Missouri when the Japanese went aboard to sign the peace treaty. We were some of the very first troops to land on Japanese soil. We landed in a place called Tateyama which is the tip of land in Tokoyo Bay. Our job was to confiscate all military material and destroy it. We loaded on their ships. They were taken out in the ocean and used as target practice for the navy planes. We patrolled the area until Dec. then headed for home. We came in at

Bremerton, WA then went on to Fort Knox where I was given my honorable discharge in Dec. 1945. I wish I could remember the dates of events but nobody cared about the dates in those days.
