1. I want to commend you and your fine battalion for the outstanding performance yesterday in negotiating a crossing of the Rappahannock River.

2. It was the first time to my knowledge that an organization of any nature, let alone the size of a battalion, reinforced by a rifle company, had effected a crossing of non-fordable river of appreciable size with their light combat equipment, including 37-mm guns and $\frac{1}{4}$ ton trucks, using expedients such as can be available to a combat organization possessing neither boats nor pontoon equipment.

3. The willingness of yourself, and of your organization, to assume the responsibility and initiative for a crossing of this nature is very praise-worthy. It is just such initiative and courage that is essential in war.

4. The military appearance of your men, their willingness and enthusiasm were most impressive and were favorable commented upon by the Commanding General VI Army Corps and visiting officers.

5. In thus commending you, I hope also to commend your officers and men for their very creditable showing.

History

TO : All Officers and Enlisted Men.

1. The Battalion Motor Vehicle Command Inspection this date in general shows a considerable improvement in First Echelon motor maintenance. I believe at last we have become motor-minded. The large number of motor vehicles entrusted to us, requires constant and vigilant attention. One of our primary and most important functions is to "keep 'em relling";

2. Capt. Joseph F. Nee, Commanding Officer, Company "C", all officers, the Motor Sergeant and drivers of this company are commended and cited for an exceptionally fine piece of work in connection with First Echelon Motor Maintenance. The inspection of the vehicles of this company today indicates that all concerned feel their responsibilities with regard to proper motor vehicle maintenance. The present condition of vehicles is the result of hard and conscientious work.

3. As of today, out of 245 motor vehicles in the Battalion, only two a re dead-lined for Third or Fourth Echelon maintenance and one of these is for body work. Four only are dead-lined for Second Echelon maintenance, two of these being for 6000-mile check, and the other two awaiting parts. This is a fine record and shows that all of us are on the job. There must be no let-up if we are to maintain this standard.

4. Efforts should now be made to improve paint appearances, especially pioneer tools.

5. 1st Lt. Harold P. Williams, as Battalion Motor Officer, is also commended for his part in the supervision and direction of motor vehicle maintenance work.
