1. In compliance with Par 10, AR 345-105, as amended by Change 3 dated 9 March 1943, the following report is submitted:

2. The information contained herein has been extracted from the Unit Journal of the 773rd Tank Destroyer Battalion.

3. Report After Operations Against the Enemy - Period Ol0001A December 1944 - 312359A December 1944.

On 1 December Battalion (Fwd CP) located in BIRINGEN, Germany (C137909). Headquarters Co. located at ST FRANCOIS (QO63836), France. Reconnaissance Company locations: Hq pltn, FLASTROFF; lst, 3rd and Pioneer Pltns, COLEMAN; 2nd pltn, DAMPONT FARMS. The three Ron pltns reconnoitered for gun positions; lst pltn in vicinity of EIMERSDORF, SEIDSDORF and HEIMERSDORF; 2nd pltn in vicinity of EIMERSDORF and 3rd pltn on high ground W of FREMERSDORF. A Co.- No action; everything quiet. Location of pltns as follows: CP (Fwd) 171870; CP (Rear) 158859; lst pltn 168857; 2nd pltn 207876; 3rd pltn 190862. B Co.- CP and all pltns (less 3rd pltn) no change. 3rd pltn moved to a position at Q213849, and pltn locaters went forward on foot to secure gun positions for direct fire into BUREN. Pltn then went into position at 223853. Location of other pltns, CP, lst and 2nd pltns, 139909. C Co. - CP and lst pltn located at SONNENHOF (Q18908980); 2nd pltn in FREMERSDORF (Q21209020). 3rd pltn moved from 18208975 and assembled at a position just SE of MONDORF where they waited for completion of bridge across stream so that they might cross and establish roadblocks in town. Weather, cloudy and rainy.

On 2 December, Bn Hqs (Fwd CP) and Hqs Co. no change. Ron Co. - All pltns remained in same positions. No activity. A Co. - The 1st and 3rd pltns remained in same positions. At 2030 hours, 2nd pltn moved to GUERLFANGEN (188883) preparatory to assembling of company from position 2078%6 where they had received sporadic enemy artillery fire throughout the day. B Co (minus 3rd pltn) no action. At 1200 hours, 3rd pltn moved to a position at '25857 in BUREN. No action. C Co. - At approximately 1100 hours, the 2nd pltn fired upon and neutralized six pillboxes across the river from FREMERSDORF. Upon request of CO, 359th Infantry, two houses suspected of being occupied by the enemy were also fired upon and destroyed. At 0615, the 1st pltn took up positions at 19909055. At 0730 hours, the 3rd pltn plus four .50 cal. MG sections took up positions at: 2 MG's at 199913; 2 MG's at 204902. Pltn at 19859125. Both pltns have commanding views of river and valley. 2nd pltn at FREMERSDORF received some enemy shelling. Weather, cloudy and rainy.

On 3 December, Ron Co. - 1st, 2nd and 3rd Ron pltns alerted for movement then taken off alert. 2nd pltn lost bivouae area to elements of a FA Bn so new position was found in NEUNKIRCHEN and movement made there at 1610 hours. No other changes. A Co. - 2nd pltn moved to FURWEILER at 1000 hours and 3rd pltn moved to FURWEILER at 1130 hours. Rear CP moved from SCHWERDORF to FURWEILER at 1030. All three pltns in assembly position doing cleaning and maintenance. CP 220863; 1st pltn 168857; rear CP, 2nd and 3rd pltns 171870. B Co. - Company minus 3rd pltn no action. 3rd pltn in -1BUREN received some artillery fire, Pltn leader de reconnaissance in vicinity of 237856 and located positions from which they could fire across the river in case such fire was needed. In the morning five PW's were captured after being driven out of a cellar. C Co. - At approximately 1100 hours, 2nd pltn fired on enemy pillboxes by request of 359th Inf. commander. Enemy artillery still active in and around all positions. 1st and 3rd pltn leaders reconnoitered for new positions. Weather, cloudy and rainy.

On 4 December, En Hqs (Fwd CP) moved from BIRINGEN (Q137909) to FURWEILER (170869) closing in at 1430 hours. Distance travelled 4 miles. Hqs and Ron Companies, no change. A Co. - remained in same location. No action. B Co. - remained in BUREN with no action. Remainder of company left BIRINGEN at 1230 and moved to FURWEILER (171869) closing in at 1330 hours. C Co. - No change in situation, no action, but enemy artillery active. Weather, clear during the day, cloudy and rainy in the evening.

On 5 December, Hqs Co. (less S-1 & S-4 sections) moved from ST FRANCOIS to BIRINGEN (Q137909). Ron Co. - Pltn leaders reported to firing companies for missions. A Co. - At 0500 hours, the 3rd pltn moved from FURWEILER to REHLINGEN (236875). At 1000 hours, 1st pltn moved to 243849. At 1430 hours, 2nd pltn moved to 219863. At 1400 hours, 1st pltn fired at eleven enemy pillboxes from ranges of 1600 to 3000 yards, but final results were not definitely known due to distance and poor visibility. All pltns were again subjected to cavy enemy mortar and artillery fire, two MIO's of 1st pltn receiving shrapnel damage. B Co. - 1st & 2nd pltns remained in FURWEILER. Pltn leaders made a reconnaissance for firing positions along the SAAR River. Hqs pltn and 3rd pltn moved to IHN (178810), closing in at 1130 hours. C Co. - At approximately 1530 hours, one gun of the 2nd pltn fired on house occupied by enemy across the river. Results unknown. FREMERSDORF continued to receive enemy stillery fire. 1st and 3rd pltns received heaviest artillery and mortar fire yet encountered. No change in positions. At 1530 hours, Colonel SPIESS, Bn CO, presented 11 Bronze Star Awards and 14 Purple Heart Awards to members of this battalion. Weather, cloudy.

On 6 December, Bn Hqs (Fwd CP) moved from FURWEILER to WALLER-FANGEN (252818) closing in at 1530 hours. Travelled 13 miles. Ren Co. - Co. CP moved from FLASTROFF to FURWEILER closing in at 1345 hours. No other change. A Co. - No change in position. All pltns were under enemy artillery and small arms fire, the 2nd pltn receiving the heaviest fire encountered to date. 1st pltn fired at and neutralized two enemy pillboxes. Visibility was fair in the afterhoon establishing a credit of 11 enemy pillboxes fired at the previous day by the 1st pltn. 'B Co. - No change. Firing pltns were alerted to cross SAAR River as soon as bridge was completed. C Co. - All pltns plus the four .50 cal. MG's fired over 15 minute periods at 0806 hours, 0858, 0923 and 1014 hours. 1st pltn fired at ranges of 900 to 1700 yards on 15 pillboxes, trenches and MG emplacements. One pillbox neutralized and numerous hits scored on all targets. 2nd pltn fired at ranges of 400 to 900 yards at 7 pillboxes, neutralizing three and scoring hits on all. HE fire was also placed on two houses reported as having enemy occupants. 3rd pltn fired at ranges of 800 to 1500 yards on 15 pillboxes quad trenches also scoring numerous hits. All pltns received some heavy enemy artillery and small arms fire during the day. At 1615 hours, the 2nd pltn moved to OBERESCH, followed by the 1st and 3rd pltns at 1900 hours. Weather, cloudy.

On 7 December 1944, Bn Hqs (Fwd CP) and Hqs Company, no change. Ron Co. - Pltns remained inactive. CP and 1st section Pioneers, FURWEILER; 1st pltn and 2nd Section Pioneers, SIERSDORF; 2nd pltn, NEUNKIRCHEN; 3rd pltn, COIMEN. A Co. - All pltns received enemy artillery fire. The 3rd pltn in position in REHLINGEN was on the receiving end of plenty of enemy automatic weapons and small arms fire zeroed in on all openings in houses near guns. 1st Ron pltn with 2nd Section Pioneers attached and located in SIERSDORF with Co. CP. B Co. - At 1715 hours, 1st and 2nd pltns moved to BUREN to an

assembly position, ready to cross SAAR River. No other change. C Co. - assembled in OBERESCH doing motor maintenance and cleaning up. Weather, cloudy and rainy.

On 8 December, Bn Hus (Fwd CP), Hus Co and Ron Co., no change. A Co. - No change except rear CP closed in with forward CP at SIERSDORF. 3rd pltn again received enemy artillery fire. B Co. - No change. Pltns awaiting transportation across the river. C Co. - No change. Vehicle and weapons maintenance continued. Weather, cloudy and rainy.

On 9 December, Hqs (Fwd CP), Hq Co. and Rcn Co., no change. A.Co. - No change in pltn positions. 1st and 3rd pltns were again on the receiving end of heavy enemy artillery fire. Sgt Ward, while returning to the 3rd pltn from the company CP discovered one dead and two wounded infantrymen about 300 yards from the CP. They had evidently been trying to secure parts from a group of wrecked vehicles, including one tank, two 6x6's and one 1/4-ton wrecked by mines. He evacuated the wounded, notified the CP and the unit to which the men belonged. B Co. - At 1530 hours, the 1st pltn moved to a position on road leading to SAAR River 1000 meters E of ITZBACH. 'As of 2400 hours pltn in same position because ferry was not completed for operation as of that time. C Co. - Remained in OBERESCH continuing maintenance and cleaning up. Weather, cloudy, rain and cold.

On 10 December, A Co. - 1st and 2nd pltns, no change. The 3rd pltn moved from REHLINGEN to SIERSDORF under heavy enemy mortar fire, closing in at Co. CP at 1800 hours. the radiators were pierced on one M10 by a very "close" one. Lt. Michaels (1st pltn Ren), Lt. Fielden (Ren), Reconnaissance Company, six EM 2nd pltn and four EM Hqs pltn, Co. A, carried supplies and equipment and helped evacuate the wounded at the ferry site under heavy enemy mortar and MG fire. B Co. - 1st pltn, less one M10 were ferried across at 0400 in support of 1st En, 358th Inf. on E side of SAAR River. Two M10's bogged down in the mud half-way between ferry site and DILLINGEN and could not be evacuated due to enemy observation and artillery fire. One M10 on the west side of river, threw a track on road to ferry approach. Heavy enemy artillery concentrations were received late in the afternoon. 2nd and 3rd pltns, no change. C Co. - At 1600 hours 2nd pltn and Co. CP moved to BUREN. No other changes; balance of company remained in OBERESCH. At 1530 hours, Col. SPIESS, En CO, presented one Bronze Star and two Purple Heart awards to members of this command. Weather, cloudy, rain and cold.

On 11 December, En Hqs (Fwd CP) and Hys Co. and Ren So., no change. A Co. - At 1700 hours, 1st pltn moved to position at Q260815. This pltn is part of a Task Force consisting of four TD's and five tanks that were to cross the SAAR River by ferry during the hours of darkness, but at 2400 hours they were still waiting to cross. The 2nd and 3rd pltns, plus 1st Ren and 2nd Section Pioneers, received heavy enemy artillery shelling during daylight hours. At 1730, the Pioneer section were employed in crossing and recrossing the river delivoring supplies and picking up wounded. B Co. - No change. C Co. - At 1330, the 2nd pltn moved into BUREN which had been shelled heavily in the past 24 hours. Weather, cloudy and light rain.

On 12 December, Bn Hqs (Fwd CP) and Hqs Co., no change. Rcn Co. - The 3rd pltn received mission of carrying supplies for 357th Inf. No other changes. A Co. - The three firing pltns crossed the river and went into the following positions in the vicinity of PACHTEN: 1st pltn, Q253845, closing in at 1115 hours; 2nd pltn and forward CP, Q252829, closing in at 1700 hours; 3rd pltn, Q239819, closing in at 1730 hours. No other changes. B Co. - 1st pltn, no change. 2nd and 3rd pltns went into position on SAAR River road on North outskirts of WALLERFANGEN and fired on suspected enemy OP's in DILLINGEN. At 1600 hours, one M10, 2nd pltn was ferried across the river and it joined the column of TD's already stuck on the far shore Remainder of company awaiting crossing at Q249845. At 2400 hours,

3rd pltn still waiting at 246844 to make crossing. Four M10's of company bogged down on both sides of river. C Co. - At 1000 hours, the 1st pltn moved from position in BUREN and went into firing position at 25008300 on heights overlooking the town of DILLIGEN. The pltn was not called on to fire, so they returned to their former position in BUREN. At 1600 hours, the 2nd pltn at NIEDER LIMBERG (25208180), alerted for river crossing. At 1730 hours, the 3rd pltn (less 1 M10) located in BUREN. No other changes. At 1430 hours, Major General VAN FLEET, 90th Infantry Division Commander presented 2 Silver Star Awards to Lt. Kenneth C. Sutter and Tee 5 Ira J. Conklin at the battalion CP. Weather, cloudy.

On 13 December, Bn Hqs (Fwd CP) and Hqs Co. no change. Ren Co. - Hqs and 3rd pltn, no change. 1st and Pioneer pltn moved to WALLERFANGEN. At 1940 hours, the 2nd pltn left NEUNKIRCHEN and reported to 357th Inf. Hqs. to act as carrying party for them. A Co. - 'All elements of company across river except rear CP and 1st Ren pltn attached, located in WALLERFANGEN (25488140). B Co. - Fwd CP in DILLINGEN, rear CP at INN. 1st pltn with one M10 in support of 358th Inf. The 2nd pltn made river crossing at 1115 going into position at DILLINGEN in support of 3rd Bn. The 3rd plm also made crossing at the same time going to PACHTEN in support of the 2nd Bn. C Co. - At 1300 hours, the company was alerted to cross the SAAR River. At 1345 hours the 2nd pltn had crossed end by 1500 hours the three pltns had completed crossing and assembled in PACHTEN (25608460) At 1630 hours the company joined 359th Infantry at 25758585, but situation warranted the use of only one, 2nd pltn, which remained in support of the 2nd Bn. The 3rd pltn returned to PACHTEN. 1st pltn unable to use RR underpass at 25658587 and were forced to remain there for the night. Colonel SPIESS, Bn CO, crossed the river and remained there through the 19th of December during which time he coordinated the statelion attack on enemy pillboxes with the infantry. Major General VAN FLEET presented 4 Silver Star Awards to the following men of the battaliof; Cpl James F. Cunningham, Tec 5 Sam Schwatz, Pvt John E. Melzer, Pvt Gilbert C. Kerr. Weather, cool and cloudy.

On 14 December, Bn Hqs (Fwd CP) and Hqs Co. no change. Rcn Co. -The 3rd pltn received mission and acted as carrying party for 357th Infantry. No other changes. A Co. - CB, 1st and 3rd pltns at PACHITEN (25408483). 2nd pltn located at 25738550. Rear CP and 1st Ren pltn atchd at 25458140. During the day 4 pillboxes were knocked out by the company. At 1900 hours the maintenance truck loaded with supplies needed on other side moved to ferry site for crossing. Co. - CP and 3rd pltn at 257844. At 0730, 2nd pltn moved in support of 358th Inf. to take one block on the E side of the RR tracks in DILLINGEN. The TD's were used to silence MG fire from emplaced positions and to protect the infantry from possible attacks by enemy armor. The one pillbox in this area was taken under fire by the 1st section at a range of 75 yards; immediately thereafter 19 prisoners, two wounded and three dead were removed from the pillbox. This enabled the infantry to move in and take the block. This was the first ground gained on the east side of RR tracks, in the city of DILLINGEN. The section continued to fire into buildings on the bordering streets and silenced machine gun fire from this sector. The 3rd pltn fired on enemy OP's during the afternoon. Results unknown. The 1st pltn with only one gun in operation saw no action. C Co. - At 0900 hours, 1st section, 1st pltn succeeded in moving through RR underpass and returned to PACHTEN. 2nd section, 1st pltn 25758585. The 2nd section, 1st pltn and 2nd pltn joined 2nd pltn at fired on two pillboxes, houses and troops in area NE of check point 206. Houses were demolished but results of firing on pillboxes unknown at this time. At 1500 hours, positions were reconnoitered at 26508390 for possible occupation by 3rd pltn. Weather, cold and cloudy.

### C-O-N-F-I-D-F-N-T-I-A-L

On 15 Decembor, bu Hqs and Hqs Co. no change Ron Co. - CP at FURWEILER. 1st and Pioneor pitus at WALLEPFANGEN. 2nd pltn at NEUNKIRCHEN, 3rd pltn at COLMEN. 2nd pltn alerted for mission with 357th Infantry, but taken off elert at 2000 hours. No other activity. A Co. - No charge in positions. Three pillboxes destroyed during day. B Co. - After having made a very thorough reconnaissance during day. B CS. - After having mode a vary thorsough reconnaissance the previous day, It. MoMahon lead the 3rd plth over the RR tracks in advance of the 2nd Bn, 356th Infantry whom he was supporting. This was a coordinated attack between the 1st and 2nd Bns to move into the town of DILLIGEN. Each of the four guns took a pillbox under fire and kept them buttoned up while the infentry moved across the hazardous zone. They continued to fire at these pillboxes until the four of them were blown by the engineers. Later in the day they knocked out a fifth pillbox on the left flank which was out of their zone but still firing on the infantry. The Bn Comdr of the supportzone but still firing on the infantry. The Bn Comdr of the support-ing infantry said that this was the finest piece of work he had ever seen by the armored forces. The one gun of the 1st pltn fired its basic load of ammunition at two pillboxes in the 1st Bn sector. A one TD, total of seven pillboxes were neutralized during the day. C Co. - The 3rd 3rd pltn damaged by running over an enemy mine. pltn in coordinated attack with 1st EA, 358th Infantry, brought fire on three pillboxes which commanded passages across RR tracks in DILLINGEN. Enemy fire from these pillboxes silenced. After crossing RR tracks took enemy strongpoint in house next to church under fire from one gun and neutralized it resulting in capture of 8 enemy and 5 enemy dead. Weather, cold and cloudy.

On 16 December, En Hqs (Fwd CP) and Hqs Co. no change. Ren Co. - At 1825 hours, the 1st, 2nd and 3rd pltns and Pioneer pltn crossed the SAAR River to the vicinity of PACHTEN to support A, B and C Companies. A Co. - No change. B Co. - 3rd pltn fired on a pillbox as the infantry advanced. This pillbox was knocked out by shots that penetrated the 6-feet of concrete. 2nd pltn relieved the 3rd pltn at 1400 hours. Heavy eneny artillery fire was received by both pltns. 1st pltn remained in reserve. One casualty suffered. C Co. - No change. 2nd pltn fired 3 rounds HE on enemy troops; results unknown. Weather, cloudy to clear.

On 17 December, Bn Hqs (Fwd CP) no change. Hqs Co. Battalion Maintenance Section moved to WALLERFANGEN. No other changes. Ren Co. - CP moved to WALLERFANGEN. No other changes. A Co. During day destroyed two pillboxes. During the day a total of 39 rounds HE, 37 rounds AP, 17 THO5 and 1000 rounds .50 cal, fired on pillboxes and troops. B. Co. No change. C. Co. - 1st and 2nd pltns no change. The 3rd pltn by request of 1st Bn, 358th Infantry fired In enemy positions in factory district in DILLINGEN, and all enemy small arms fire from that sector was silenced. The officer assignments were changed and the ompany commanders are as follows: Hq Co. Captain RICHARD; Ren Co. Captain KELLY; A Co. Captain WILLIAMS; B Co. Captain EMHARDT; C Co. Captain MAIDA. Captain PATERSON assumed the S-3 position in place of Captain BLOMQUIST who was injured and evacuated to a hospital on the 15th of December. Weather, cloudy and cool.

A forward aid station was set up in the vicinity of PACHTEN and immodiately started to function with Captain SINGER, S/Sgt Slutsky and Tec 3 Geisenhoffer treating wounded infantrymen, tankers and civilians until they were withdrawn on 22 December. A Co. - 1st and 2nd pltns moved to 267844. No activity. B. Co. -1st pltn relieved 3rd pltn C Co. and now located at 269842. 2nd pltn moved to 282849. No other changes. C Co. - the 3rd pltn moved back to CP in PACHTEN. No activity. During the period 13 to 18 December, inclusive, Major MOORE, Bn Executive Officer, coordinated moving supplies across river for the battalion and also visited positions of allfiring companies. Weather, cloudy and rain.

### C-O-N-F-I-D-E-N-T-I-A-L

On 19 December, En Hqs, no change Hqs Co. (less En Maintonance) moved to WALLERTANGEN closing in at 1650 hours. Ron Co. - 2nd and 3rd pltns alerted to move to EIRINCEN and OBERESCH, respectively. As of 2400 hours they were still being ferried across the river. 1st pltn and Pioneers remained with A Co., A. Co. - 1st and 2nd pltns moved to positions in DILLINCEN and 3rd pltn moved to position North of PACHTEN. No other changes. B Co. - Company alerted for move to BIRINGEN for counterattack. At 2400 hours company plus 3rd Ron pltn atchd completed river crossing for move to BIRINGEN. C Co. - 1st pltn by request of infantry fired on pillbox and K)'d same. At approximately 1800 hours company left PACHTEN, crossed river and assembled at OBERESCH (15208550) by 2330 hours. At 1000 hours, Lt. Beckman was presented the Silver Star Award by Major General VanFLEET, 90th Infantry Division Co, at the 358th Inf headquarters. Weather, cool and cloudy.

On 20 December, Bn Hqs (Fwd CP) and Hqs Co. no change. Roh Co. - 2nd and 3rd pltns with B and C Companies reconnoitered territory to the North of BIRINGEN and OBERESCH. A Co. - CP, 26008500 1st pltn 25858499, 2nd pltn 26998450, 3rd pltn 25908550. Pioneer pltn atchd at CP. 1st Ren pltn atchd with 2nd pltn. Company remained in support of 90th Infantry Div in defense of DILLINGEN bridgehead. B. Co. - No change. Co. located in BIRINGEN. C Co. - No change. Co. located at OBERESCH. Weather, cool and cloudy.

• On 21 December, Hqs (Fwd CP) no change. Hqs Co. moved from WALLERFANGEN to HALSTROFF closing in at 2100 hours. Ren Co. -Co. CP moved from WALLERFANGEN to FLASTROFF (128361). The Pioneer pltn atchd to A Co. destroyed the following: 2 disabled MlO's at PACHTEN, 2 - 2½ 6x6 (Chemical Company vehicles) and 1 75mm German AT gun. They prepared a bridge for demolition which was to be blown by engineers. At 1600 hours, the Pioneers crossed the SAAR River and proceeded to FLASTROFF. The 1st pltn completed crossing the river by 1700 hours. A Co. - Co2 remained in support of 90th Infantry Div in defense of DILLINGEN. Alerted to the SAAR for withdrawal. B Co., - Located in BIRINGEN. Pltn leaders made a reconnaissance to the M and NE in the event of an attack. At 1700 hours, company moved to HALSTROFF closing in at 1800 hours. C Co. - Co. continued reconnaissance to the North. No other changes. Weather, cold and light snow,

On 22 December, Bn Higs (Fwd CP) moved from WALLERFANGEN to HALSTROFF closing in completely by 1200 hours. Heavy enemy mortar nd artillery fire was falling in WALLERFANGEN while moving out. Distance travelled 15-miles. Hqs Co. - No change. Ron Co. - Lt. Michaels (1st pltn) still in PACHTEN. He destroyed one 1/4T vehicle due to inability to recross river, but the MG was salvaged. Lt. Michaels and driver crossed river at 0200 hours completing all of company crossing. 3rd pltn in RITZING making move with C Co. from OBFRESCH. The pltn made a reconnaissance for gun positions along line BUSENDORFF to OBER-TUNSDORF, also line from LAUNSTROFF, WELLING-TON and BUDING. A Co. - At PACHTEN started crossing SAAR River at Oll5. The first two MlO's were crossed by a push and pull ferry. At 0530 hours, seven TD's were across and also all of the infantry leaving the rest of the TD's on their own. Good smoke, a little snow, hard-working men and men who stuck to their vehicles allowed them to get all vehicles across by 0930, except one 1/4T of 1st Ron pltn which was stuck so bad it could not be evacuated. Hard, steady work of Major MOORE and Captain WILLIAMS was a great help to all During the move from PACHTEN to the ferry site, heavy concerned. artillery and mortar fire was received everywhere. The company closed in at HALSTROFF at 1400 hours. B Co. - Co. was alerted to move but remained in present location at HALSTROFF.
