BRIEF SUMMARY OF BATTALION OPERATIONS DURING PERIOD OF THIS REPORT.

BATTALION: (Atchd IV Corps Reserve)

106 Cav

On 18 Sept 44 1st Bn left at CHARLES 227707, near CP at CHARLES 220707. At 1630hrs 1st Bn ordered to attack two cos to 106 Cav - rest of Bn in IV Corps Reserve. Cos A & C were to join 106 Cav by the C.P. and then establish a base forward of 7/1000. Co B took up defensive positions in BRANTIGNY. Contact and liaison was established with French 2nd Div; 106 Cav Co; 77th T.D. Bn. A 3rd T.D. Co. From the above notification of their being awarded Bronze Stars.

On 19th Sept Co C moved to CHARLES from CHARLES. 1st Bn took up pos. in BRANTIGNY. 2nd Bn and 3rd Bn via 106 Cav (contact was established along with C troop of 106 Cav and T.D. Co). Attacks made at 1800hrs and at 1900hrs. 106 Cav was hit. Cos A fired 20 rds H.K. & A.F.; 10 A.F.O. and 200 rds Cal. 50 cal.

Two M4 IV tanks were badly damaged by our fire, one possibly destroyed. Co A fired 75 rds H.K. destroying 5 enemy vehicles, killing and wounding from 40 to 50 inf. infantry in this sector. Co B remained in defensive pos at BRANTIGNY.

On 20th Sept 1944 Co A established W/ 106 Cav in vic of PORTIGNY and then moved to vic 00412 (Louvain sup 106 1/100,000) Co B in Brantigny; Cos in vic Roselioures; Co C in pos via of REHAUVILLER (0044) W/ 106 Cav near REHAUVILLER 0044.

On 21 Sept Co C fired 35 rds H.K. at the village 100000 retreating toward MARCH. into FORT DE MARCH. Extent of damage unknown. Co A CP 00000, 1st Platoon STABLE; 2nd and 3rd Platoon 00000. Co C CP 00000; 1st Platoon via of 00000 (assumed).

On 22 Sept at 0700 Co C left CP 227707 (CHARLES) followed by Co B (near loc BRANTIGNY) and Co A. (near loc Charles 220707) setting up camp. CP in REHAUVILLER near L'INTE (001007 at 1800hrs. At 1900hrs Co C moved out through MARCH to REHAUVILLER. 1st Bn took approx 30 miles. Co A 1st Platoon, cos. attached.

Co B set up FDC with 1st Platoon in REHAUVILLER from 0800hrs 23 Sept to 0800hrs 24 Sept. Co B fired 2000 rds H.K. via REHAUVILLER range 10,000 to 14,000 yds. 20 missions ind. com. fire. For reg. 10 rds 50 cal exp. at 1800hrs 24 Sept for re-registr. Co B exp 14 rds 50 cal between 0800hrs 24 Sept 0800hrs 25 Sept Co B fired 31 missions ind fire com exp. 10 rds 50 cal at 0800hrs 25 Sept 1730A Co C's

BRIEF SUMMARY OF BATTALION OPERATIONS DURING PERIOD OF THIS REPORT.

From positions in REHAINVILLER and later in LUNEVILLE, from the period 2050 hrs, 23 Sept to 0600 hrs, 1 Oct, Co B fired 518 missions ind conc fire (XV Corps arty working w/182 FA Bn) - expending 6745 rds HE, 115 rds SMK. Corps arty reported very satisfactory results obtained. Upon moving to REHAINVILLER, Co B had set up its FDC there; later moved to LUNEVILLE (present location) and set up FDC w/guns in ind fire pos there.

As of 26 Sept, Cos "A" & "C" ordered atchd 106 Cav w/Co B still in Corps reserve for ind fire missions. See above.

On 25 Sept, Co C moved 14 miles NE to vic RECHICOURT (152139) w/pls in pos on high ground S & E. Co atchd to Trp A 121 Cav; mission: to intercept enemy forces seeking to escape through woods to N from PARROY FOREST. Enemy infantry in numbers of about one bn to one regt were observed in sector and the three pls exp a total of 103 rds HE direct fire. Co A in vic LUNEVILLE received hvy enemy arty fire. Co B in REHAINVILLER, also Bn CP.

On 26 Sept, Bn CP and Rcn Co moved to LUNEVILLE. Pioneer pl removed road block, cleared mines and booby traps vic of Bn CP. Co B remained in REHAINVILLER on ind fire missions for Corps arty. Co A in LUNEVILLE. Co C's 1st pl was detachd from 121 Cav and atchd to 106 Cav taking up defensive pos at JOLIVET. 2nd & 3rd pls atchd to 121 Cav, 2nd pl taking up pos at BONVILLER; 3rd pl taking up pos vic EINVILLE. Pls closed in above pos at 1800 hrs.

On 27 Sept, Rcn Co moved vic REHAINVILLER; one sec establ OP vic EINVILLE. Co C CP moved vic LUNEVILLE (008079) and pls which had taken up pos N of LUNEVILLE moved back behind bomb line establ by XV Corps. Co A moved into ind fire pos at (050010); FDC set up at (052001); OP set up at (082020). Pls registered exp 34 rds HE, 3 rds SMK. Ordered to cease fire by 106 Cav and assemble at 1630 hrs whereupon pls returned to Co at LUNEVILLE at 1850 hrs. Co B moved from REHAINVILLER to LUNEVILLE where it set up FDC; pls went into ind fire pos and continued to fire ind conc, Corps Arty missions.

On 28 Sept, Co A, at 1300 hrs, 2nd & 3rd pls left LUNEVILLE; 2nd pl w/C Trp 106 Cav; 3rd pl w/A Trp. 2nd pl went into pos at (115069); 3rd pl at (108075). At 1400 hrs, Co CP and 1st pl moved to EINVILLE (076068); 1st pl in reserve w/B Trp 106 Cav. At 1745 hrs, 3rd pl fired 15 rds HE at BAUZEMONT. At 1850 hrs, moved into pos (124079) firing 36 rds HE, 3 rds APC at HENAMENIL. At 1745 hrs, 1st pl moved into ind fire pos at (070060) firing 84 rds HE. During night, received hvy mortar and arty fire from enemy; no casualties. Total ammo exp far day: 125 rds HE, 3 rds APC. Co B from ind fire pos in LUNEVILLE supported attack of 79th Inf Div on FORET DE PARROY firing 97 Corps arty missions. Co C pls moved into pos 2200 yds W of BAUZEMONT; 2nd & 3rd pls firing 189 rds HE on enemy in BAUZEMONT w/1st pl in support. At 1830 hrs, friendly tanks entered BAUZEMONT; 75 PWs taken by 121 Cav. 1st pl on high ground 500 yds from town while friendly tanks entered, then moved to vic VALNEY. 2nd & 3rd pls in ind fire pos on high ground overlooking BAUZEMONT. Co C CP at SERRES (065109).

On 29 Sept, Co A, atchd to 106 Cav Sqdn, destroyed four Mk IV tks, two Mk V tks, one g-track, two hvy trucks. All except two vehicles were fired on until burned, in areas #1 & #2 (See Overlay). Enemy btry of (7) SP guns neutralized at Pt #6. At Pt #7, at 1800 hrs, 29 Sept, enemy vehicles were brought under ind fire after which no motors were heard. During this action, approx 80 enemy inf were killed as result of Co A's firing HE, and one mortar was knocked out. During this attack by the enemy, Co C was atchd to 121 Cav Sqdn. Co C destroyed eight Mk IV tks, one g-track, one mortar in areas 3 & 4 (See Overlay). All above vehicles fired upon until burned. Co C also fired

HE into enemy inf estimated at 200, estm killed 10. An enemy OP neutralized at Pt #5. Rcn Co, which has been reinforced by one spare M-10, destroyed one Mk IV tk in area 4. 30 Sept-results of the day's action were sent in full detail to 5th TD Gp, XV Corps, 79th Inf Div - See G-2 report, 79th Inf Div, No 101 from 292200 to 302200 in which a full account is set forth.

30 Sept - Co A - 2nd pl pos under enemy arty fire throughout day. At 1730 hrs, one sec 3rd pl moved to (124079), firing 13 rds HE at a steeple used as OP by enemy in HENAMENIL. 1st pl fired 205 rds HE in ind fire missions during day. Rcn Co loc vic EINVILLE (078074). Co's M-10 w/3rd pl at BETHLEMONT (108110). Rcn OP was shelled throughout day. Co's M-10 fired 40 rds HE into enemy OP & sub pos in this area. Co C's 1st pl fired HE into sector of BAUZEMONT, reported that of three enemy tanks in that sector, two of them were knocked out by the 126 rds HE ind fire of Co C. This was a Cav report but Co C does not confirm it and does not take credit for these destroyed enemy vehicles.

1 Oct. -- Rcn Co CP EINVILLE (078074) w/OP in BETHELMONT-LES-BAUZEMONT, Co M-10 there. Remnants of Co engaged in maint (6000 ml check) of vehicles. Co CP at SERRIS (065109). Co A at 0800 hrs, 1st pl relieved 2nd pl at (114064); 2nd pl moved to ind fire pos of 1st pl (070060) registering their guns and expending 145 rds HE on ind fire missions.
