1. By direction of the President, and under the provisions of AR 600-45, as amended, and Memorandum No. 34, Headquarters Ninth United States Army, 8 September 1944, as amended, the Bronge Star Medal was awarded per General Orders No. 95, this headquarters, dated 22 November 1944, to:

Private George L. Humphrey (Army Serial Number 34121055), Field Artillery, Company "B", 814th Tank Destroyer Battalion, United States Army, for distinguishing himself by heroic service in connection with military operations against an enemy of the United States on 28 October 1944, in the area of Asten, Holland. While he was serving as cannoneer, Pvt Humphrey's platoon was engaged in the mission of maintaining a road block on the Asten-Meijel route, effectively preventing the movement of enemy troops. When a Mark VI tank approached within 200 yards of his vehicle, he kept steadfastly at his post, even though the gunner repeatedly failed to bring his gun into action. Despite continuing fire from small arms, mortars and 88mm guns, Pvt Humphrey remained with his vehicle, even after it had sustained a direct hit from the enemy tank. Although wounded himself, Pvt Humphrey helpted evacuate the wounded gunner from the destroyer. His courageous devotion to duty reflects the highest credit upon Pvt Humphrey and the military service.

Staff Sergeant Stephen W. Lander (Army Serial Number 33266894), Field Artillery, United States Army, for distinguishing himself by heroic service in connection with military operations against en enemy of the inited States on 28 October 1944, in the area of Neerkant, Holland. When his platoon took up a defensive position along the Asten-Meijel road, S/Sgt Lander demonstrated outstanding initiative in maintaining communications between the widely-separated destroyers. Although under intense fire from enemy artillery and anti-tank guns, he kept unremittingly at his liaison work. In the face of superior enemy armored forces and constantly infiltrating German infantry troops, he supervised the evacuation of the crew of a burning tank destroyer. Even after all supporting troops had withdrawn, S/Sgt Lander stayed with the last remaining destroyer, 2000 yards ahead of the rest of his unit, preventing enemy vehicles from using the road.

Leeper (Army Serial Number 37652005), Field Artillery, Company "B", 814th Tank Destroyer Battalion United States Army for distinguihsing himself by heroic service in connection with military operations against an enemy of the United States on 28 and 29 Catober 1944, in the area of Asten, Holland. While he was serving as driver, Pfc Leeper assisted in maintaining a road block on the important Asten-Meijel route, effectively preventing the approach of enemy vehicles. 1. By direction of the President, and under the provisions of AR 2600-45, as amended, and Memorandum No. 34, Headquarters Ninth United States Army, 8 September 1944, as amended, the Bronze Star Medal was awarded per General Orders No. 95, this headquarters, dated 22 November 1944, to:

Corporal Willie Mays (Army Serial Number 38079547), Field Artillery, while serving with the Army of the United States, distinguished himself by heroic service in connection with military operations against the enemy on 28 October 1944, in the area of Asten, Holland. While he was serving as gunner, Cpl Mays' platoon was engaged in maintaining a road-block on the Asten-Meijel route. Although mechanical difficulties prevented operation of his weapon, Cpl Mays remained at his gun in the face of four Mark VI tanks, which approached within 200 yards. Five times he vainly endeavored to fire his gun. As their vehicle was endeavoring to withdraw it was hit by a high explosive shell, which seriously wounded Cpl Mays. His magnificent devotion to duty during a most critical situation reflected the highest credit upon Cpl Mays and the Armed Forces.

as cannoneer, Pvt Merrill's platoon was given the mission of maintaining a road block more than a mile forward of the other vehicles of his
battalion. Although exposed to constant enemy fire, he determinedly
kept at his position, even after supporting infantry troops had been
forced back. After being surrounded by enemy infantry and sighted by
four German tanks, Pvt Merrill's vehicle was ordered to withdraw from
its untenable position. Breaking through a cordon of hostile troops
at high speed, their vehicle sustained a direct hit in the turret, injuring the entire crew. By his aggressive action and devotion to duty,
Pvt Merrill set an outstanding example of valor, which reflects the
highest credit upon himself and the military service.

By direction of the President, and under the provisions of AR 600-45, as amended, and Memorandum No. 34, Headquarters Ninth United States Army, 8 September 1944, as amended, the Silver Star was awarded per General Orders No. 95, this headquarters, dated 22 November 1944, to:

Corporal (then Private) Leo L. Murray (Army Serial Number 37544692), Field Artillery, United States Army, for distinguishing himself by gallantry in action on 29 October 1944, in the grea of Neerkant, Holland. When the tank destroyer in which he was serving as gunner set up a road-block, Cpl Murray's accuracy with the veh cle's cannon accounted for five of the enemy's heaviest tanks, the Mark VI Tiger. Allowing the Germans to come within four hundred hards of his position to increase the effectiveness of his fire, he helped repulse four assaults by formations that outgumed our own forces. In the last of them, concentrated shelling from four tanks fired Cpl Murray's tank destroyer and forced him out of the action. By his courage and ability he aided greatly in the successful operations that denied use of the important Asten-Meijel highway to the enemy.

While he was serving as gunner, Cpl Myrum's platoon was engaged in maintaining a road block on the Asten-Meijel route, effectively preventing the approach of enemy vehicles. For an hour and a half he engaged in a fierce duel with a Mark VI tank. Exhibiting superior marksmanship, Cpl Myrum scored fifteen direct hit on the enemy tank, but the rounds were unable to penetrate the heavy armor. During the course of the duel, his destroyer was hit and set ablaze, and Cpl Myrum suffered a serious wound. His outstanding skill and courageous devotion to duty reflect the highest credit on Cpl Myrum and the Armed Forces.

During the fiercely contested engagement along the Asten-Meijel road, Pfc Ruiz defied the heaviest fire to deliver important messages between the company command post and the platoon positions. Hiding a light, unarmored vehicle through intense artillery, mortar, antitank and small arms fire, he maintained constant communication with the various elements of the company. So strong was the enemy resistance that at times he had to crawl for hundreds of yards to accomplish his mission. Completely disregarding his own safety, he hepeatedly went to the aid of wounded soldiers, and evacuated them from the fire-swept field. His unremitting efforts and courageous conduct throughout the battle reflect the greatest credit upon Pfc Ruiz and the Military Service.

S Sgt Rutka deployed his platoon in road-block positions that denied the enemy the use of the vital Asten-Meijel highway, despite almost constant tank attack. Waiting until the Germans were within point-blank range, he directed fire which took a heavy toll of enemy manpower and equipment. When all four tank destroyers were badly damaged, he finally withdrew, leaving eight burned-out Mark VI Tiger tanks on the road. During the engagement, his platoon also destroyed an observation post set up in a church steeple. All during this fiercely-contested ection, S Sgt Rutka displayed outstanding heroism and leadership worthy of the highest praise.

Disregarding the pain from his own injury, he entered the balazing turret and attempted to evacuate the gun commander and loader, beating back the flames with his hands. When other men from the company arrived to finish the job, Pfc Walstrom unhesitatinly went to the aid of two of his comrades and by his heroic action helped save their lives.

Advancing against the concentrated fire of three German Tiger tanks, Pfc Thomason's tank Destroyer participated in an assault on an enemy position, destroyed ing two and damaging the remaining hostile vehicle. Although shells were bursting in close proximity to his tank destroyer, Pfc Thomason performed his duty as cannoneer coolly and with great dispatch. short time later, in defending the Asten area against encroaching German troops, he assisted in the destruction of numerous enemy concentrations including a building occupied by 50 German soldiers. Moving forward as an observer, he selected targets and directed effective fire on a number of hostile installations. When his own tank destroyer was struck five times by enemy fire and burst into flames, Pfc Thomason ran 1000 yards to join another crew of his battalion. By his aggressive and courageous conduct, Pfc Thomason became an inspiration to his entire company.

Sergeant Charles W. Beagle (Army Serial Number 32072486), Field Artillery, Company "B", 814th Tank Destroyer Battalion, United States Army, for distinguishing himself by heroic service in connection with military operations against an enemy of the United States on 27 and 28 October 1944, in the area of eijel, Holland. While attached to Reserve Command, 7th Armored Division, Sgt Beagle's gun crew set up a position on the Asten-Meijel road, denying the enemy use of this vital highway. Under elmost constant artillery and small arms fire and suffering from a recurrence of malaria, which he had contracted while serving in the African campaign, Sgt Beagle refused to leave his gun. Finally, when his temperature rose to 102 degrees, he was ordered to the rear. His devotion to duty when in danger from disease as well as enemy action, reflects great credit upon Sgt Beagle and the Armed Forces.
