# 18 June 1943

S Sgt Clayton H. Kitts 35 326 973, was driving a six by four, two and a half ton GMC kitchen truck to Camp and was travelling east on Copperas Cove Road about two miles outside of Camp gates at approximately 25 miles per hour. A Platoon of men from the 302d Ordnance Company were travelling west on the left side of the read. There were about six (6) or eight M-10's travelling alonf the side of the road on a dirt trail. The dust interfered with Kitts vision causing him to run into this platoon killing seven (7) EM and injuring one officer and 14 FM. This accident was declared unavoidable by the investigating officer.
