SUBJECT: Organization of Tank Destroyer  
Units in July, 1942.

TO: Commanding Generals,  
\*\*\*

1. The units listed on the attached inclosure are constituted and will be activated as indicated on the inclosure as early in July, 1942, as availability of personnel, housing and other facilities permit. Activation will not take place until commissioned personnel is available. Subject to the above, the exact date of activation will be determined by the Commanding General, Third Army.

2. Cadres.

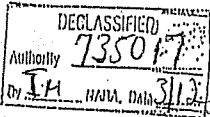
a. Enlisted cadres will conform to those in Tables of Organization. Cadre men need not hold the grades indicated in Tables of Organization, but must be qualified to perform the duties of the positions for which they may be selected.

b. Each cadre will be moved to the station of activation on call of the Commanding General, Third Army.

c. Each unit furnishing a cadre is authorized overstrength in grades equal to that of the cadre. Requisitions to this office for such overstrength will be marked "cadre equivalent."

d. Promotions to cadre grades and to fill vacancies may be made within 60 days prior to the transfer of a cadre to a new unit.

e. Should a source unit be ordered out of the Continental United States before the cadre is withdrawn, the cadre will be left at the station at which the source unit is serving at the time of receipt of orders and the source unit will notify the Commanding General, Army Ground Forces, that the cadre is available.



f. Both commissioned and enlisted cadres should be at the station of activation at least 15 days, and preferably 30 days, before a unit receives its fillers.

3. Grades to new units will be authorized in accordance with letters, this office, AG 221 (1-18-42) EA-A, January 21, 1942, subject, "Allotment of Grades and Ratings and Authorized Strengths to Tactical Units (less Air Corps and Services with Air Corps)", and AG 221 (4-3-42) EA-A, April 6, 1942, subject, "Staff Sergeants (Grade 3) in Lieu of Mess and Platoon Sergeants (Grade 4)",

4. Fillers, including attached medical personnel, will be requisitioned from this office by the Commanding General, Third Army.

5. Officers

a. Commanders and key personnel for Separate Battalions. (See paragraph 3b, letter, this office, AG 320.2 (12-15-41) OP-A-M, December 26, 1941, subject, "Officer Filler and Loss Replacements for Ground Arms and Services".)

b. Officers accompanying enlisted cadres. Units furnishing enlisted cadres will provide one officer of company grade per company cadre to accompany each cadre to the station of activation. The officer accompanying each cadre will then become a part of the officer complement of the new unit upon its activation.

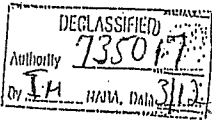
c. Remainder of officer complement. In providing the remainder of the officers, the Commanding General, Third Army will utilize commissioned personnel available for such assignment, including officers who may have been selected by the Commanding General, Army Ground Forces, and provided in anticipation of the activation. Requisitions for necessary additional officers will be submitted to this office.

6. Controlled items of equipment will be furnished units in accordance with the priorities indicated on the attached inclosure. (See letter, this office, AG 400 (3-6-42) (MSG-D-M, March 8, 1942, subject, "Distribution of Controlled Items of Equipment"). Field Force commanders will expedite the submission of requisitions for other items of equipment.

7. Direct correspondence is authorized.

8. Date of activation will be reported to the Commanding General, Army Ground Forces, and this office without delay.

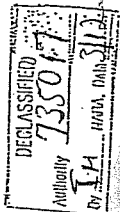

1. Pursuant to authority contained in letter, Army Ground Forces, 321/17 (TD Units)(R)(2 July 43)GNGCT, subject: Reorganization of Tank Destroyer Battalions, dated 2 July 1943, the following Tank Destroyer Battalions will be reorganized, by the Commanders indicated, at the earliest practicable date in accord with T/O 18-35, dated 7 May 1943, with an authorized strength of thirty-two (32) officers, two (2) warrant officers, and seven hundred sixty-three (763) enlisted men:

2. Personnel.

a. No enlisted men will be reduced in grade as a result of this reorganization unless for other reasons prescribed in Army Regulations and War Department directives.

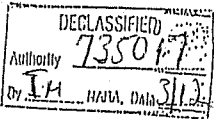
b. These units are allotted an initial overstrength in grade seven equal to Table of Organization cadre strength.

c. So much of letter this headquarters, file 320 (TD Units)-GNTDA, dated 20 March 1943, subject: "Reorganization of Tank Destroyer Battalions Pursuant to T/O 18-25 et seq, dated 27 January 1943," as is in conflict with this directive is rescinded.

d. Selection of surplus personnel made available for transfer will be in accord with either one, but not both, of the following plans:

- (1) Surplus personnel will be those whose immediate preceding assignment was at a reception center or a replacement training center. Of this personnel those who arrived most recently will be transferred in the order of their dates of arrival, starting with the last man assigned to the battalion. When the condition arises wherein the arrivals of one particular day must be segregated between surplus personnel and personnel to be retained, surplus personnel will be selected alphabetically beginning with the letter A.
- (2) Surplus to be transferred will represent a proper proportion of distribution of each of the five intelligence groups as they existed in the battalion prior to such distribution.

e. Attention is directed to paragraph 2 e. of letter referred to in paragraph 2 c. above, concerning character requirements of selected surplus personnel.

f. No enlisted man will be transferred on whom administrative action is pending relative to reclassification or discharge.

g. The Classification Officers of the Advanced Unit Training Center and the Basic Unit Training Center, respectively, will inspect all soldiers' qualification cards and service records of the units concerned to verify that the surplus reported is in accord with the procedure outlined above.

h. Reports will be rendered this headquarters not later than 15 July 1943, indicating the following:

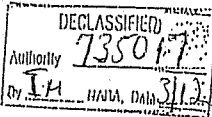
- (1) Roster of surplus personnel by grade, name, serial number, AGCT group (I, II, III, IV, or V) character rating, efficiency rating, and disciplinary record.
- (2) Number of personnel in the unit (prior to reorganization) falling in each of the five intelligence groups as determined by the highest AGCT score reported on the Soldier's Qualification Card.

3. Equipment.

a. Additional organization equipment required will be supplied in accord with T/E 18-36, T/E 18-37, 7 May 1943, and T/E 18-25-M, 27 January 1943, insofar as availability permits. For individual equipment, T/E 21, 10 March 1943, will govern. For training equipment, T/A No. 20, 10 March 1943, will govern.

b. Any excess equipment will be released to the Commanding General, Tank Destroyer Center.

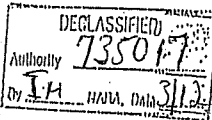


