Effective August 27, 1942, each of the above named enlisted men of the Enlisted Reserve Corps is called to active duty and will proceed from Cleveland, Ohio to the Reception Center, Camp Perry, Port Clinton, Ohio reporting to the Commanding Officer thereof for assignment and duty.

The Transportation Officer, Examination and Induction Board No. 1, Cleveland, Ohio will furnish the necessary transportation. It being impracticable for the Government to furnish rations in kind, meals for the required number of men will be furnished under provisions of AR 30-2215 for such meals as the length of the journey may require at a rate not to exceed \$0.75 per meal or not to exceed \$1.00 per meal per man when meals are taken in the dining car. The travel directed is necessary in the military service and is chargeable to FD 34 P 434-02 A 0425-23.
